**BACKGROUND:** (Continued)

Two additional months of soil technicians, welding inspections, and ultrasonic inspections were not included in the original scope of work within the contract. As a result of these additional services, Amendment No. 1 will compensate MTGL in the additional amount not-to-exceed \$44,328.

All costs associated with this project will be fully funded by the RCRMC Enterprise Fund, thus no net county costs will be incurred.

2 **BY AND BETWEEN THE COUNTY OF RIVERSIDE**

5 **CUSTODY/URGENT CARE/SEXUAL ASSAULT RESPONSE TEAM**  
6 **EXPANSION PHASE 1, 2, AND 1**

7 **THIS FIRST AMENDMENT TO THE AGREEMENT FOR PROFESSIONAL**  
8 **SERVICES** for Testing and Inspection Services ("First Amendment") is made and  
9 entered into by and between the COUNTY OF RIVERSIDE, ("COUNTY"), and MTGL,  
10 herein referred to as "CONSULTANT".

11 **RECITALS**

12 **WHEREAS**, the COUNTY entered into the Original Agreement with  
13 CONSULTANT on February 8, 2011("Original Agreement");

14 **WHEREAS**, the COUNTY has determined that additional services are needed  
15 and CONSULTANT has agreed to provide such additional services to COUNTY;

16 **NOW, THEREFORE**, in consideration of the mutual covenants contained herein  
17 and providing that all other sections not amended remain in full force and effect, the  
18 parties hereto agree as follows, effective January 1 2012 :

19 I. Section 1. SCOPE OF SERVICES of the Original Agreement is hereby amended  
20 to add the following sentence at the end of the first paragraph:

21 "CONSULTANT shall provide the additional professional services, as outlined  
22 and specified in Exhibit "A-1", consisting of one (1) page, attached hereto and  
23 incorporated herein by this reference.

24 II. Section 2. PERIOD OF PERFORMANCE of the Original Agreement is hereby  
25 amended by removing the reference to 248 calendar days and replacing with  
26 April 30, 2012.

27 III. Section 3. COMPENSATION of the Original Agreement is modified to change the  
28 not to exceed amount of the Agreement to One Hundred Seventy Eight  
Thousand Eight Hundred Fifty Two (\$178,852.00).



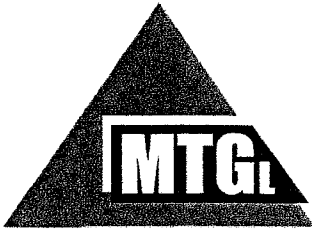

These costs are a direct result of unanticipated conditions encountered over the beginning stages of the project.


Estimates shown are based on work performed eight hours per day, Monday through Friday and are based on current prevailing wage rates.
