SUBJECT: Amendment to the Professional Services Agreement between Blood Bank of San Bernardino / Riverside Counties d/b/a LIFESTREAM and Riverside County Regional Medical Center (RCRMC)

RECOMMENDED MOTION: Move that the Board of Supervisors:

- 1) Approve the increase to amend the current contract agreement to add an additional \$21,798 for FY 2011/2012;
- 2) Ratify and authorize the Chairman to execute the renewal amendment between Riverside County Regional Medical Center and Lifestream to provide Therapeutic Apheresis (TA) services for an aggregate amount of \$87,193, effective July 1, 2012; and
- 3) Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise renewal options, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation provision that do not exceed ten percent of the annual amounts.

SUBJECT:

Amendment to the Professional Services Agreement between Blood Bank of San Bernardino / Riverside Counties d/b/a LIFESTREAM and Riverside County Regional Medical Center (RCRMC)

BACKGROUND:

Riverside County Regional Medical Center (RCRMC) has contracted with Blood Bank of San Bernardino/Riverside Counties to provide blood product & blood-related services since 1991 and for the Therapeutic Apheresis (TA) program since 1999. Historically, this vendor has been the sole provider able to supply these needed services for the hospital.

On August 31, 2010; agenda item 3.70, the Board of Supervisors approved the multi-year professional services agreement(s), without securing competitive bids, in accordance with Ordinance 459.4, for a term of three years ending June 30, 2013 for the blood product & blood-related services not to exceed \$6,814,500 and for the (TA) program not to exceed \$140,000. These two contracts would run simultaneously.

RCRMC anticipated spending approximately \$46,667 per year for the TA program. Due to an unexpected need for the TA service during the first fiscal year, the department used approximately 52% of the contracted amount as several patients required the needed service. In anticipation of unexpected service utilization, RCRMC is requesting additional funds for the current fiscal year and additional funds for the final fiscal year 2012/2013 of the contract.

Therefore, the Hospital Director requests that the Board of Supervisors approve the abovementioned motions.

FISCAL FUNDING:

These services are based solely on Hospital Enterprise Funds (100%).

FIRST AMENDMENT TO THE AGREEMENT

WITH

**BLOOD BANK OF SAN BERNARDINO AND
RIVERSIDE COUNTIES d/b/a LIFESTREAM**

(Therapeutic Apheresis Program Services)

That certain Agreement between County of Riverside ("COUNTY") and **Blood Bank of San Bernardino and Riverside Counties d/b/a LIFESTREAM**, (CONTRACTOR"), initially executed by the County Board of Supervisors August 31, 2010; Agenda Item No. 3.70, is hereby amended as follows:

1. On page 3 of 28, Section **4.0 Compensation**, amend to include the following:

"4.2.1 COUNTY shall increase the contract amount for year 2 of 3 (FY 2011-2012) for an additional twenty one thousand seven hundred ninety-eight dollars (\$21,798)"

"4.2.2 Maximum payments by COUNTY to CONTRACTOR shall not exceed eighty seven thousand, one hundred ninety-three dollars (\$87,193) for the period of the Agreement from July 1, 2012 through June 30, 2013, unless terminated as otherwise provided herein."

2. All other terms and conditions of the Agreement are to remain unchanged.


