SUBJECT: Transfer of Pre-Trial Services from the Superior Court of California to the Riverside County Probation Department, and Amend Ordinance No. 440 pursuant to Resolution 440-8899. submitted herewith.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1. Amend Ordinance No. 440 pursuant to Resolution 440-8899 submitted herewith, and.
- 2. Authorize the purchase of 10 vehicles for use in the Pre-Trial Services program and countywide implementation of pretrial field supervision services.

BACKGROUND: On February 15, 2012, in a letter from the Superior Court of California, the court provided official notice that it will no longer administer Pre-Trial Services on behalf of the County of Riverside, effective July 1, 2012.

Pre-Trial Services is a county responsibility, its purpose is to provide a process of evaluating the feasibility of releasing defendants from custody based on a set of predetermined criteria such as family ties, criminal history and previous failures to appear. The overall mission of the program is the investigation of individuals to determine release eligibility in an effort to reduce incarceration costs and jail overcrowding while taking into account public safety by providing a risk assessment and community supervision.

The Criminal Justice Realignment Act, or Assembly Bill (AB) 109, effective October 1, 2011, provided expanded authority to the Probation Department to use alternative programs to detention for incarcerated defendants, including pretrial defendants, such as electronic monitoring, home detention and other programs. The Probation Department also has the ability to supervise pretrial defendants released with special conditions, such as drug testing and counseling, and to report violations to the court.

Previously, Own Recognizance (OR) releases were granted in 6% of the defendants recommended for release by pretrial staff. This number is expected to increase by adding a risk assessment and a community supervision component to pretrial services. The Probation Department intends on utilizing the COMPAS (Correctional Offender Management Profiling for Alternative Sanctions), pretrial risk assessment tool on every eligible inmate, approximately 1,000 a month. The Probation Department also intends on implementing field supervision services countywide.

Supervision strategies will include home and office visits, Kiosk reporting, electronic monitoring, drug testing, treatment referrals and any other conditions of release that may be ordered by the court.

Pre-Trial inmates are estimated to be approximately 66% of the current jail population. By relying on a successful evidence-based risk and needs assessment tool as well as adding the accountability of countywide supervision services, the Probation Department will be able to increase the amount of OR release recommendations being made to the court, thus making room for post-sentence cases.

<u>Budget</u>

The costs associated with Pre-Trial Services are the responsibility of the county pursuant to *California Rules of Court* 10.810. The county, as part of the Memorandum of Understanding between the court and the county, has previously reimbursed the court for the actual costs incurred for managing and overseeing the activities associated with Pre-Trial Services.

The Probation Department, upon notification that the Pre-Trial Services program would be transferred to the county, included 18 new positions and funding in the fiscal year 2012/13 recommended budget that was due in March 2012. The Probation Department realized that as the transfer and implementation process progressed, there would be a need to return to the Board of Supervisors requesting additional positions, equipment, and potentially additional funding to successfully complete the transfer and implementation of the Pre-Trial Services program and the countywide field services supervision component.

The recommended motions to amend the Ordinance No. 440, adding 16 positions, and to authorize the purchase of 10 vehicles previously not budgeted in the fiscal year 2012/13 recommended budget will provide the additional resources required to fully transfer the Pre-Trial Services program, successfully apply the evidence based assessment supervision services, and to implement field supervision services countywide.

The resolution amending Ordinance No. 440 has been reviewed and approved by Human Resources.
