SUBJECT: Initiation of Amendments to Ordinance No. 348 Relating to Zoning and Ordinance No. 555

Implementing the Surface Mining Act of 1975

#### **RECOMMENDED MOTION:**

- 1. Adopt an order initiating an amendment to Ordinance No. 348 that would revise the fast track project procedures and the definition of a fast track project contained therein.
- 2. Adopt an order initiating an amendment to Ordinance No. 555 that would allow for surface mining permits and accompanying reclamation plans to be processed pursuant to the fast track procedures established in Ordinance No. 348.
- 3. Direct the Planning Department and County Counsel to prepare and process the ordinance amendments.

#### **BACKGROUND:**

Currently, Ordinance No. 348 does not allow for surface mining permits and their accompanying reclamation plans to be processed pursuant to the fast track procedures established in Ordinance No. 348. Additionally, Ordinance No. 555 does not allow for such permits and reclamation plans to be processed pursuant to the fast track procedures set forth in Ordinance No. 348. These proposed ordinance amendments would allow the potential for surface mining permits and their accompanying reclamation plans to be processed pursuant to the fast track procedures established in Ordinance No. 348 as is authorized for all other land use entitlements.

Applications for any surface mining permit and reclamation plan would still need to be designated as a fast track project by a majority vote of the Board or by the EDA Director as set forth in Board of Supervisors Policy A-32 in order to be processed pursuant to the fast track procedures.

RE: Board Agenda Item 3.84 Revisions to Fast Tracking

Dear Chairman Tavaglione and Members of the Board:

This letter is sent on behalf of Save Our Southwest Hills and the 40,000 residents who signed petitions opposing Liberty Quarry. I have been an urban planner for 39 years and actively involved in environmental planning in California for the past 20 years. During this time it has become obvious that the two projects that have the most impact on the environment and quality of life are quarries and landfills. Projects which are suspected of having or are known to have significant environmental impacts simply are not the sorts of projects that should be fast tracked. Supervisor Benoit's proposal that would make mining projects subject to fast tracking is not only ill conceived but smacks of backroom dealing and political paybacks. It is these types of projects where it most important to have the disinfectant of public scrutiny. To do anything to limit public debate is to invite criticism from those who might think that government has been corrupted by special interests putting political payback above the public interest and trust.

When dealing with very complex projects such as mines, it is precisely times like those when the expertise and experience of the Planning Commission is most important. When rushing complex projects such as these, it is all too easy to miss critical mitigation measures and conditions of approval.

As a matter of course, in all cases of fast tracking, the Supervisor in whose district the Project is located should be required to be among those approving fast tracking since they are the ones who will receive the public blame for trying to fast track a project and restrict public review and comment on a Project. Thank you for your consideration.

Re: Proposed Action to Place Surface Mines into the County's Fast Track Program (Item 3.84 July 31, 2012 Agenda)

Honorable Chairman and Members of the Board:

The City of Temecula urges you vote no on the proposed motion to put mines on the County's fast track program that is part of Item 3.84 on your July 31, 2012 Agenda.

Surface mines are among the most complex and controversial land use projects in any city or county and Liberty Quarry is at the top of the list. This Board and the Riverside County Planning Commission quite appropriately provided significant opportunities for the public to comment on the Liberty Quarry Project. The Board should be grateful for the opportunity to have all of the issues relating to such complex projects discussed and evaluated by many different people in the course of public hearings before the Planning Commission as well as the Board. It is only from these discussions and evaluations that the people can be confident that the Board is basing its decision on all available facts and opinions. Public participation and debate is not meant to be efficient—it is meant to result in the best possible decisions for the community.

Government Code Section 65033 emphasizes these policy considerations in establishing State policy with respect to public participation in the planning process:

"65033. The Legislature recognizes the importance of public participation at every level of the planning process. It is therefore the policy of the state and the intent of the Legislature that each state, regional, and local agency concerned in the planning process involve the public through public hearings, informative meetings, publicity and other means available to them, and that at such hearings and other public forums, the public be afforded the opportunity to respond to

clearly defined alternative objectives, policies, and actions." [Emphasis added.]

In addition to the public policy issues at stake in this motion, the Board must also take into account two legal considerations.

First, the motion seeks an amendment to Ordinance No. 348, the County's Zoning Ordinance. As an amendment to the Zoning Ordinance, Government Code §§ 65854-65858 and CEQA Guidelines § 15378(a)(1) require that the County analyze the amendment's environmental impacts, prepare the necessary CEQA documents, hold public hearings before the Planning Commission and hold public hearings before the Board of Supervisors. The proceedings necessary to adopt the proposed change in the Zoning Ordinance will undoubtedly take far more time than the time required to hold public hearings before the Planning Commission on the new Liberty Quarry surface mining permit. What then will the Board obtain by this adopting motion other than furthering distrust of government?

Second, we question the County's legal authority to use the fast track process for any project, let alone surface mining. The Government Code requires public hearings before the Board of Supervisors and a "planning agency" as discussed above. Government Code § 65100 provides that the Planning Agency can be the Board or the Planning Commission or a hearing officer. This Government Code section does not, however, authorize the Board to pick and choose what projects it wants to send to the Planning Commission and which ones it does not. This is especially true where the Board has delegated the decision of what projects may or may not go on fast track to a non-elected County official, the Executive Director of the County Economic Development Agency. There may have been some limited authority for this process under redevelopment, but redevelopment is dead and whatever limited authority may have existed under redevelopment is now gone as well.
