SUMMARY OF EVIDENCE

- Documents of record in the Riverside County Recorder's Office identify the owners of THE PROPERTY as Cora L. Buckley, Trustee of the Cora L. Buckley Revocable Living Trust Dated November 25, 2002 ("QWNER").
- 2. Documents of title indicate that other parties potentially hold a legal interest in THE PROPERTY to wit: Floy Henry, as Trustor and Trustee of the Floyd Henry Living Trust dated September 23, 1995, The County of Riverside and Century One Builders of Arizona, Inc. ("INTERESTED PARTIES").
- THE PROPERTY was inspected by Code Enforcement Officers on May 14, 2009, July 23, 2009, November 30, 2009, September 3010, September 23, 2010, October 26, 2010, December 1, 2010, and April 22, 2011.
- 4. During each inspection, the outside storage of materials and accumulation of rubbish were observed on THE PROPERTY. The materials and rubbish were intermingled and included but were not limited to: discarded furniture and appliances, lawn equilibrent, exercise equipment, mattresses, toys, wood, metal, cardboard, plastic and miscellaneous housefold items. The officer visually estimated the amount of accumulated rubbish and excess outside storage of materials was approximately six thousand three hundred (6,300) square feet. Given the size of the parcel (2.08 acres) and the zoning classification (A-1-1, Light Agriculture), two hundred square feet of outside storage is allowed on THE PROPERTY.

Nos. 348 and 541 were posted on THE PROPERTY. On May 27, 2009, Notices of Violation were mailed to OWNER by certified mail with return receipt requested. On October 29, 2010, Notices of Violation were mailed to INTERESTED PARTIES by certified mail with return receipt requested.

On April 6, 2011, the "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notice of the public hearingbefore the Board of Supervisors scheduled for April 26, 201 was mailed by certified mail, return receipt requested, to OWNER and INTERESTED PARTIES via certified mail with return receipt requested and was posted on THE PROPERTY on April 12.

RADINGS AND CONCLUSIONS

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on April 26, 2011 finds and concludes that:

WHEREAS, the excess outside storage of materials and accumulation of rubbish on the real property located at 19600 Brown Street, Perris Riverside County, California, also identified as Assessor's Parcel Number 318-160-038 violates Riverside County Ordinance Nos. 348 (RCC Title 17) and 541 (RCC Title 8) and constitutes a public nuisance. Under Riverside County Ordinance No. 348, the parcel that is 2.08 acres in size is allowed two hundred (200) square feet of outside storage of materials to be stored on THE PROPERTY. Under Riverside County Ordinance No. 541, no amount of rubbish is allowed to be accumulated on THE PROPERTY.

WHEREAS, the OWNER, occupants or any person having possession or control of the premises shall abate the condition by removal of all outside storage of materials and removing and disposing of all accumulated rubbish from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance Nos. 348 (RCC Title 17) and 541 (RCC Title 8) within ninety (90) days.
