

**BACKGROUND:** Community Improvement Designation funds will be used to support TruEvolution's Leadership Academy which is a 25 week course at the University of Riverside California focused at providing students, aged 14-18, with the basics in time management, financial planning, life coaching and college preparedness (life skills) - project management, public speaking, team-building (leadership development) - and social action project planning and community volunteering (community engagement). Community Improvement Designation funds will also be used to support Million Kids and their "The Love Trap" Program which empowers kids to avoid being exploited and coerced into prostitution, pimping, selling rings and sex exploitation.

**I request that the Board of Supervisors approve a contribution of \$14,000 to support these programs.**


