SUBJECT: Acceptance of a Grant Award from the California Department of Parks and Recreation

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Authorize the Sheriff or his designee to sign and execute the Project Agreement with the California Department of Parks and Recreation, Division of Off-Highway Motor Vehicle Recreation, accepting a grant award of \$51,147 for overtime salary devoted to the Off-Highway Vehicle Enforcement Program.
2. Authorize the Sheriff, or his designee to administer the grant, sign payment requests, progress reports, future amendments and/or modifications not increasing the award by more than 20% on behalf of the County;
3. Approve and direct the Auditor-Controller to make the budget adjustments on the attached Schedule A.

BACKGROUND: From September 20, 2002 (3.32) through September 13, 2011(3.79) the Board accepted grant funding for the Riverside County Off-Highway Vehicle Enforcement program (ROVE).

On March 20, 2012 (3.27), the Board adopted Resolution #2012-053, that authorized the Sheriff to apply for \$203,340 in grant funds from the State to continue the specialized patrol program in all five Supervisorial Districts.

In response to the County's application, the California Department of Parks and Recreation has now awarded the Sheriff's Department \$51,147. The grantor requires a County cash or in-kind match of 25% of program costs, or at least \$17,049. The Sheriff's Department will utilize budgeted ROVE car pool expense for the County's in-kind grant match.

Schedule A details budget adjustments in the amount of \$51,147. The grant project term is from 7/1/12 to 6/30/13. County Counsel has approved the Project Agreement as to form.
