**SUBJECT:** Volcano Fire Claim Settlement Authority

**RECOMMENDED MOTION:** That the Board of Supervisors approve modification of the settlement authority of the Human Resources Department, Risk Management Division, from \$50,000 per occurrence to \$50,000 per individual property owner for claims arising from the Volcano Fire.

**BACKGROUND:** On August 1, 2012, a fire broke out in the La Cresta area and it burned approximately 350 acres resulting in the loss of one home and lesser damage to other homeowners in the area. At the August 28, 2012 Board of Supervisors meeting, the Board directed the Human Resources Risk Management Division to establish an expedited process to review claims for loss and work with insurance companies or homeowners to resolve claims in an appropriate and timely fashion. The authority provided to Risk Management by the Board's approval of this motion will assist Risk Management's ability to meet that directive.
