SUBJECT: Approval to waive Board Policy K-3 Telecommuting Program for the Department of Public Social Services

RECOMMENDED MOTION: That the Board of Supervisors waive Policy K-3, Telecommuting Policy, for the Department of Public Social Services through March 31, 2013.

BACKGROUND

The Department of Public Social Services (DPSS) is exploring alternative work options and is planning to create a pilot telecommuting program that will run from October 1, 2012 through March 31, 2013 with a limited number of staff across all programs. DPSS will use the pilot to assess the ability to fulfill DPSS service requirements from remote locations. The results of the pilot could impact our approach for expanding services while also having the potential of reducing environmental impacts. DPSS is requesting that Board Policy K-3 be waived to allow the department the flexibility to administer the pilot program. The current policy includes provisions that could limit the scope of our pilot, such as restricting the number of days that an employee may telework.
