BACKGROUND: (Continued)

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 16, 2009 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 5, 2009. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 4, 2009, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

3) Claim from U.S. Financial Funding, LLC, Power of Attorney for Sondra A. Levy AKA Sondra Levy based on an Assignment of Right to Collect Excess Proceeds dated March 1, 2010; a Grant Deed recorded February 8, 1991 as Instrument No. 46045; the death certificate of Jack Levy and a Special and Limited Power of Attorney dated September 10, 2010.

Claim from Global Discoveries, Ltd., assignee for Ruth Kirschner, Successor Trustee of The Jack Levy Trust dated September 25, 2007 based on an Assignment of Right to Collect Excess Proceeds dated July 23, 2009, a Quitclaim Deed recorded October 15, 2007 as Instrument No. 2007-0638143, the death certificate of Jack Levy, a Certification of Trustees under Trust and Declaration of Trustee dated July 23, 2009 and a Certification of Trust Agreement dated September 25, 2007.

Pursuant to Section 4675 (a) & (b) & (e) of the California Revenue and Taxation Code, it is the recommendation of this office that the State of California, Franchise Tax Board be awarded excess proceeds in the amount of \$1,387.59, Easy Loan Corp. be awarded excess proceeds in the amount of \$16,061.94, U.S. Financial Funding, LLC, Power of Attorney for Sondra A. Levy AKA Sondra Levy be awarded excess proceeds in the amount of \$23,295.18 and Global Discoveries, Ltd, assignee for Ruth Kirschner, Successor Trustee of The Jack Levy Trust dated September 25, 2007 be awarded excess proceeds in the amount of \$37,969.52. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

Dear Ms. Potenciano:

I represent Global Discoveries, Ltd. ["Global"] with respect to its excess proceeds claim relating to Riverside County Tax Assessor's Parcel Number 908-220-054-4 ["the Subject Property"]. The Subject Property was sold by the County at its Tax Sale on March 16, 2009 as Item Number 333. As a result of the sale the County holds excess proceeds for distribution in the amount of \$79,244.00. Global has asked that I correspond with you regarding issues which you have raised to Global's excess proceeds claim arising from the tax sale of the Subject Property.

Ownership of the Subject Property

The history of the ownership of the Subject Property is:

- Jack Levy ["Jack"] and Sondra A. Levy ["Sondra"], husband and wife, acquired the Subject Property as Joint Tenants pursuant to a Grant Deed recorded in the Official Records of Riverside County on February 8, 1991 as Document No. 046045.
- On May 12, 2000, Sondra filed for dissolution of her marriage to Jack. According
 to the Court's docket, Sondra never served the Petition for Dissolution of Marriage
 on Jack, and no hearings were ever held in the proceeding.
- At some point, Jack moved out of the Subject Property and established a new residence at 27755 Whisperwood Drive, Menifee, California 92584.

- On September 25, 2007, Jack established the Jack Levy Trust Dated September 25, 2007 ["the Trust"]. Jack was the Trustor and the original Trustee of the Trust. Jack's friend Ruth Kirschner ["Ruth"] was the first Successor Trustee of the Trust.
- On September 25, 2007, Jack conveyed his interest in the Subject Property to the Trust by a Quitclaim Deed which was recorded in the Official Records of Riverside County on October 15, 2007 as Document No. 2007-0638143.³ As will be explained below, the recordation of this deed severed the joint tenancy between Jack and Sondra, and thereafter the Trust and Sondra held title to the Subject Property as joint tenants.
- Jack died on December 21, 2007.⁴
- Sondra's dissolution proceeding was dismissed by the Court on October 3, 2008.
- On March 16, 2009, the County sold the Subject Property at its annual tax sale.
- On July 23, 2009, Ruth as Trustee of the Trust assigned the rights to claim the Trust's 50% interest in the excess proceeds from the tax sale to Global.⁵

Global's Excess Proceeds Claim

On July 30, 2009, Global filed a claim as the assignee of the Trust. The Claim included:

- the Claim Form executed by Jed Byerly, Global's Chief Operations Officer
- the Assignment of Right to Collect Excess Proceeds executed by Ruth as Trustee of the Trust

A Certification of Trust Agreement executed by Jack on September 25, 2007, a Certification of Trustees under Trust (California Probate Code Section 18100.5) executed by Ruth on July 23, 2009, and a Declaration of Trustee executed by Ruth on July 23, 2009, were submitted with Global's Claim.

Ruth married Irwin Lawrence Gerstenfeld on October 2, 2008, and is now known as "Ruth Gerstenfeld." Copies of the Gerstenfeld's Marriage Certificate, Ruth's California Drivers License, and a Declaration of One and the Same Person executed by Ruth were submitted with Global's Claim.

A copy of the recorded Deed was submitted with Global's Claim.

A copy of Jack's Death Certificate was submitted with Global's Claim.

The original Assignment of Right to Collect Excess Proceeds was submitted with Global's Claim. The Assignment was on a standardized form which Global has used and the County has accepted on tens if not hundreds of prior claims.

- the September 25, 2007 Quitclaim Deed by which Jack conveyed his 50% interest in the Subject Property to the Trust
- A Certification of Trust Agreement executed by Jack on September 25, 2007, a
 Certification of Trustees under Trust (California Probate Code Section 18100.5)
 executed by Ruth on July 23, 2009, and a Declaration of Trustee executed by Ruth
 on July 23, 2009
- Jack's Death Certificate [Ruth was the informant]
- Ruth's Marriage Certificate for her 2008 marriage to Irwin Gerstenfeld
- a Declaration of One and the Same Person executed by Ruth attesting to her identity,
 and
- a photocopy of Ruth's California Drivers License

These documents establish that the Trust was the owner of a 50% tenants in common interest in the Subject Property prior to the County's tax sale, and prior to its recordation of its deed to the tax sale purchaser, and also establish Ruth's status as the Successor Trustee of the Trust and a proper claimant of the excess proceeds pursuant to *California Revenue and Taxation Code*, Sections 4675 (e)(1) and (f).

Legal Analysis

Global advises that you have questioned the Trust's status as a 50% tenant in common owner of the Subject Property, and whether the Trust is entitled to any of the subject excess proceeds. Based upon California law I do not believe that this is subject to question or dispute. Let me explain:

The termination of joint tenancies is governed by *California Civil Code*, Section 683.2, which sets forth the requirements for severing a joint tenancy, which provides, in pertinent part:

- "(a) Subject to the limitations and requirements of this section, in addition to any other means by which a joint tenancy may be severed, a joint tenant may sever a joint tenancy in real property as to the joint tenant's interest without the joinder or consent of the other joint tenants by any of the following means:
- (1) Execution and delivery of a deed that conveys legal title to the joint tenant's interest to a third person, whether or not pursuant to an agreement that requires the third person to reconvey legal title to the joint tenant.

> (2) Execution of a written instrument that evidences the intent to sever the joint tenancy, including a deed that names the joint tenant as transferee, or of a written declaration that, as to the interest of the joint tenant, the joint tenancy is severed."

Estate of Mitchell (1999) 76 Cal. App. 4th 1378 mirrors Section 683.2, and provides that a joint tenant may sever a joint tenancy in real property unilaterally by (1) executing and delivering a deed to a third person, (2) executing a deed to him- or herself, (3) executing a written declaration of severance, or (4) executing any other written instrument evidencing an intent to sever the joint tenancy.

Severance of a joint tenancy extinguishes right of survivorship, and the remaining owners hold title as tenants in common. Re v. Re (1995) 39 Cal. App. 4th 91, 95 - 96. As the Re Court stated:

> "A joint tenancy is a unique combination of rights which can only be created by written instrument. [California Civil Code, Section] 683.5 Estate of MacDonald (1990) 51 Cal.3d 262, 271; California Trust Co. v. Bennett (1949) 33 Cal.2d 694, 697; Estate of Seibert (1990) 226 Cal.App.3d 338, 341. The California Supreme Court has held: "[F]our unities are essential to an estate in joint tenancy: unity of interest, unity of time, unity of title, and unity of possession. The requirement of four unities reflects the basic concept that there is but one estate which is taken jointly; if an essential unity is destroyed the joint tenancy is severed and a tenancy in common results." Tenhet v. Boswell (1976) 18 Cal.3d 150, 155; Hammond v. McArthur (1947) 30 Cal.2d 512, 514. Severance of the joint tenancy extinguishes the right of survivorship which is the principal feature of the estate. Estate of Propst (1990) 50 Cal.3d 448, 455; Tenhet v. Boswell, supra, 18 Cal.3d at p. 155. As our Supreme Court observed in Estate of Propst, supra, 50 Cal.3d at page 455, "[A] joint tenant's right of survivorship is an expectancy that is not irrevocably fixed upon the creation of the estate; it arises only upon success in the ultimate gamble - survival - and then only if the unity of the estate has not theretofore been destroyed by voluntary conveyance; by partition proceedings, by involuntary alienation under an execution, or by any other action which operates to sever the joint tenancy." Section 683.2, subdivision (a)(1) and (2) provides that, in addition to any other means, a joint tenancy may be severed by a conveyance of title by a deed to third party. Also, it may be severed by execution of a written instrument that establishes intent to sever the joint tenancy." [Emphasis added.]

With respect to real property, California courts have consistently applied the common law principle that an indisputable right of each joint tenant is the power to convey his or her separate estate by way of gift or otherwise without the knowledge or consent of the other joint tenant and to thereby terminate the joint tenancy. Estate of Propst (1990) 50 Cal.3d 448, 456.

This is true even where the joint tenants are husband and wife, and even though they are engaged in dissolution proceedings. Estate of Grigsby (1982) 134 Cal. App.3d 611. In Grigsby, the spouses owned their marital home as joint tenants. The wife unilaterally severed the joint tenancy by deeding her interest in the property to a straw man, who immediately deeded it back to her. Days later, the wife died, leaving her interest in the property to her sister by will. The husband claimed that the wife's attempt to sever the joint tenancy was ineffective, and that he therefore took her 50% interest by right of survivorship. The appellate court rejected the husband's claim.

The Grigsby court held the wife could unilaterally sever the joint tenancy. It acknowledged that "[t]he policy and purpose of section 1242 of the Civil Code is to prevent the destruction or encumbrance of a homestead by either spouse acting alone "Estate of Grigsby, supra, 134 Cal. App.3d at 616 - 617. The Grigsby court explained, however, that "... the termination of the joint tenancy merely changes the form of ownership and permits the cotenant to exercise his right to make a testamentary disposition of his property." Estate of Grigsby, supra, 134 Cal.App.3d at 618. The Grigsby court concluded: "We hold that the decedent did not intend to and did not injure. destroy, terminate, or encumber the homestead by exchanging deeds with the straw man. We hold that she did not intend to and did not 'transfer' her title to the property, but rather that she intended to and did convert a joint tenancy to a tenancy in common." Estate of Grigsby, supra, 134 Cal.App.3d at 618.

Grigsby is directly on point with this matter. Jack's actions herein were taken solely to terminate the joint tenancy, and to ensure that his interest in the Subject Property passed to his heirs, and not to Sondra from whom he was separated and who had previously filed to dissolve their marriage. Pursuant to Grigsby, this was a perfectly legal and ethical transaction by Jack to protect his rights. The result of Jack's recordation of his 2007 Quitclaim Deed to the Trust is that the Trust now owns 50% of the Subject Property as tenants in common with Sondra, who owns the remaining 50% tenants in common interest.

Pursuant to California Revenue and Taxation Code, Section 4675, the parties' interests were "of record" prior to the County's tax sale, and prior to its recordation of its deed to the tax sale purchaser. As such, both the Trust and Sondra are parties of interest, and each is entitled to claim and receive 50% of the excess proceeds. I trust that the County will makes its distributions in accordance with these well-settled legal principles. Should you disagree, I would ask that you please provide me with the rationale for the County's position.

- Any and all title reports or other documents which the County relied upon to determine the identity and/or address of the parties of interest entitled to notice of the right to claim the excess proceeds from the tax sale of Riverside County Tax Assessor's Parcel Number 908-220-054-4 pursuant to California Revenue and Taxation Code, Section 4676.

Legal Authority for CPRA Request

Public policy requires all public records and documents to be available for public inspection to prevent secrecy in public affairs. When there is no contrary statute or countervailing public policy. the right to inspect public records must be freely and liberally allowed. Copley Press, Inc. v. Superior Court (1998) 63 Cal. App. 4th 367. All public records, therefore, are subject to disclosure unless the Legislature has expressly provided to the contrary. Haynie v. Superior Court (2001) 26 Cal. 4th 1061, 1068; Williams v. Superior Court (1993) 5 Cal. 4th 337, 346; Teamsters Local 856 v. Priceless, LLC (2003) 112 Cal. App. 4th 1500, 1510. California Government Code, Section 6255 places the burden of justification on the agency seeking to withhold disclosure. See, e.g., New York Times Co. v. Superior Court (1990) 218 Cal. App. 3d 1579.

The Public Records Act does not differentiate among those who seek access to public information. It imposes no limits upon who may seek information or what he may do with it. California Government Code, Section 6257.5; American Civil Liberties Union Foundation v. Deukmejian (1982) 32 Cal.3d 440, 451; see also Black Panther Party v. Kehoe (1974) 42 Cal. App.3d 645, 656. What is material is the public interest in disclosure, not the private interest of the requesting party; Section 6255 does not take into consideration the requesting party's profit motives or needs. State Board of Equalization v. Superior Court (1992) 10 Cal. App. 4th 1177, 1190 - 1191; see also, Comment, The California Public Records Act: The Public's Right of Access to Governmental Information (1976) 7 Pacific L.J. 105, 118 - 119.

As used in the CPRA, the term "public records" includes any writing containing information relating to the conduct of the public's business prepared, owned, used, or retained by any state or local agency regardless of physical form or characteristics. California Government Code, Section 6252(e). As used in the CPRA, the term "local agency" includes a county; city, whether general law or chartered; city and county; school district; municipal corporation; district; political subdivision; or any board, commission or agency thereof; other local public agency; or entities that are legislative bodies of a local agency. California Government Code, Section 6252(a). As used in the CPRA, the term "member of the public" means any person, except a member, agent, officer, or employee of a federal, state, or local agency acting within the scope of his or her membership, agency, office, or employment.

In light of the statutory definitions and the case and statutory law providing for broad rights of inspection, it is clear that the records which my clients and I are requesting are reviewable pursuant to the CPRA. They are "public records" held by a "local agency" (i.e., the Riverside County Treasurer-Tax Collector). Global and I are clearly "members of the public."

Based upon the foregoing, will you please provide me with copies of the requested documents as soon as possible. My client is prepared to pay the County's costs of copying the documents.
