

- Whereas,** October is National Energy Awareness Month, and October 30 is designated as National Weatherization Day; both of which are nationally observed events that recognize the Weatherization Assistance Program; and,
- Whereas,** *Community Action Partnership of Riverside County (CAP Riverside)*, has administered the Weatherization Assistance Program for 32 years, and joins in these national observances to illustrate the importance of home weatherization and energy conservation programs to the residents of Riverside County and to encourage qualifying residents to take advantage of these programs; and,
- Whereas,** the Weatherization Assistance Program not only saves energy through advanced technologies to improve the energy affordability for low-income families, but also saves lives and improves the health and safety of families by identifying carbon monoxide hazards, poor indoor air quality, mold, and other health threats; and,
- Whereas,** CAP Riverside provides a variety of federal, state and private resources that serve people throughout Riverside County as a vital part of its overall efforts to help low-income people gain basic necessities that enable them to advance toward self-sufficiency; and,
- Whereas,** it is important to recognize the significance of these programs that ensure that all residents, especially those living at or below the federal poverty level, have the opportunity to live in energy efficient, healthy, safe, and comfortable homes as provided for by the Weatherization Assistance Program;

Now, therefore, let it be known, that the Riverside County Board of Supervisors does hereby proclaim October, 2012 as **Energy Awareness Month**, and October 30, 2012 as **Weatherization Day** in the County of Riverside.
