- 4) Authorize the Purchasing Agent to sign future contract amendments with ALAC and CDPH limited to the shifting of funds between budgetary line items as needed to facilitate the delivery of program services. Any amendments which would alter the original approved total grant award, or change any given fiscal years revenues, or modify the lifetime of the grant will be brought to the Board of Supervisors for approval.

**BACKGROUND:**

The California Department of Public Health (CDPH) has awarded funding for Refugee Health activities to the County of Riverside Department of Public Health, Disease Control Branch in the amount of \$113,250. Out of this amount, \$104,350 is designated to ALAC and \$8,900 for Riverside County administrative costs.

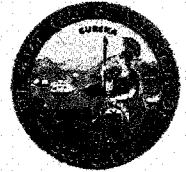
These funds support Refugee health screening, education and prevention activities. It is a collaborative effort between the California Department of Public Health, Refugee Health program and the American Lung Association in California.

The \$113,250 funding has been included in Fiscal Year 2012/2013; therefore no budget adjustment is requested.

**THIRD AMENDMENT TO THE AGREEMENT**  
**WITH**  
**AMERICAN LUNG ASSOCIATION**

(Refugee Health)

That certain Agreement between the COUNTY OF RIVERSIDE DEPARTMENT OF PUBLIC HEALTH ("COUNTY") and American Lung Association of California ("CONTRACTOR"), approved on February 9, 2010. Item 3.13, amended for the first time on October 19, 2010, Item 3.10, amended for the second time on January 10, 2012, Item 3.20, is hereby amended for the third time as follows, effective October 1, 2012:

1. To amend all references to the period of performance from October 1, 2011 through September 30, 2012 to October 1, 2012 through September 30, 2013.
2. To establish the amount of compensation for one hundred four thousand, three hundred fifty dollars (\$104,350), including all expenses.
3. To amend Attachment A, Award Funding Table, to include Award #12-33-90840-00 from the California Department of Public Health and its money distribution.
4. All other terms and conditions of this Agreement are to remain unchanged.
