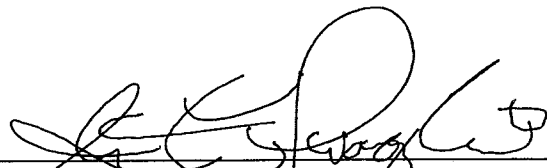
Section 1. The foregoing recital is true and correct.

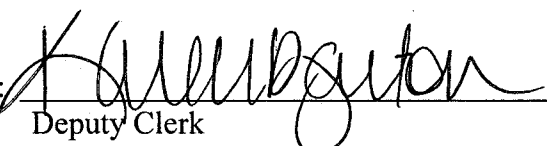

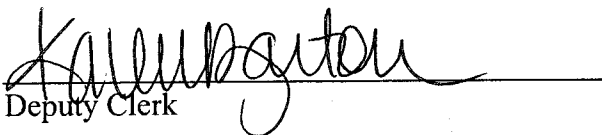

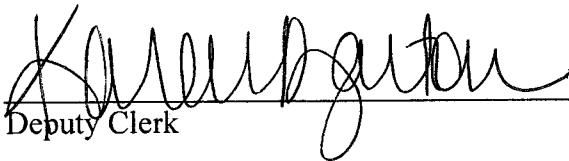
