Dear Emergency Manager:

On Thursday, October 18, 2012, the state is supporting The Great California ShakeOut, the fourth annual statewide public earthquake drill. Operational Areas have an extremely important role to play: By encouraging your constituents and stakeholders to take just five minutes to practice how they will protect themselves during a major earthquake, will help ensure that residents, local businesses, non-profits and organizations are prepared.

In the past years, we have had a number of stark reminders of the need for earthquake and tsunami preparedness: The damaging earthquakes impacting Calexico and Eureka, California; the events in Haiti, Chile and Samoa; and most recently, the Honshu, Japan earthquake that resulted in the 2011 California Tsunami reinforce what we know: strong shaking from the next "great" earthquake could cause injury and damage in locations across the state. *Seventy five percent* of our country's earthquake hazards resides in California, and it is important to remember that earthquake damage is not just an issue for our offices and employees in the Bay Area and Southern California. History shows that regional faults can cause all populace areas of the State to be subject to strong damaging shaking. Recent tsunami events demonstrated that tsunami is not just an issue for those who live and work near the ocean. The vast majority of deaths from the Chile tsunami were among visitors to the coast.

Each Operational Area can select from several simple options to participate in ShakeOut. These need not be an arduous imposition on your normal business operations:

- Register the participation of each Department at www.shakeout.org;
- Provide *Drop Cover and Hold On* information to all employees in advance of the drill;
- Instruct all available employees to practice *Drop Cover and Hold On* at 10:18 a.m. on October 18, 2012, or at a time that week that meets business considerations;
- Discuss or provide earthquake and tsunami information to employees relating to individual and family disaster preparedness.

The drill may also be used as an opportunity to review building or Departmental emergency plans, test communications call-down lists, or publicize ShakeOut to constituents.
