RECOMMENDED MOTION: That the Board of Supervisors:


1. Approve and direct the Auditor-Controller to make the budget adjustments applicable to Fiscal Year 2011/12 as listed in Attachment A.

BACKGROUND: After the end of each fiscal year, the Executive Office reviews the position of all county departments/agencies and recommends action to the Board as appropriate. Typically, adjustments are required to balance a department's budget to its actual revenue and expenses. This year the cleanup process was divided into two phases. The first phase took place early September so that timely decisions related to discretionary spending were made. The adjustments in attachment A are related to funds that do not affect the General Fund and do not have any bearing on discretionary spending decisions.


