Dear Members of the County Board of Supervisors,

As a Temecula Valley Unified School District Governing Board member I am committed to ensuring the health and well-being of our children and I want to point out a couple pieces of key data from the research presented in the Planning Commission public hearings and before the Board of Supervisors last year.

1. The health impacts found in Exhibit I and Exhibit IV of the PCR Corporation Services Reports supplied to you by the City of Temecula, February 3, 2012 are attached here. Each year 650 children will have days of restricted activity; 128 will have increased cough; 30 will have shortness of breath; 47 will have additional wheezing; 24 will have lower respiratory tract problems. Every other year a child will end up in the emergency room. This study does not analyze deaths in infants and small children. Numerous studies show infant's and children's immature lungs are more adversely impacted by poor air quality than adults. Therefore, it can be expected that the infant and child death rates will be higher than that found for adults, which was two a year.
2. Taking the corrections in air quality data supplied by the SAGE report of January 3, 2012 (See attached) into account the air quality impacts will be greater than the EIR originally indicated: "levels of PM10 at an off-site receptor will exceed the annual State of California standard by a factor of 5;" (SAGE January 30, 2012 page 1) This would in turn increase the number of children with breathing problem, restricted days of activity, wheezing, ER visits and mortality outlined in the PCR Report by a factor of 5.

Additionally, ground level dust studies were not conducted on the fields or playgrounds of our schools downwind from the proposed Liberty Quarry. Research shows that contamination near the ground where children play is higher than the levels recorded by elevated air quality monitors.

Lastly, the new application does not limit blasts to one a day, which the old application did. The new application allows for the possibility of multiple blasts each day. Each blast has the same air quality impacts as the previous application. The TVUSD Board of Governors unanimously opposed the new application of Liberty Quarry last month out of concern that it will put in jeopardy the health of hundreds of children every year who attend schools downwind and in close proximity to the proposed mining site.

You were right to be concerned about children's health when you denied Liberty Quarry the first time based on the significant impacts on air quality outlined in the Environmental Impact Report. Please deny the reapplication of Liberty Quarry again based on your original concerns about children's health.
