ORDINANCE NO. 452.233

**AN ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING ORDINANCE NO. 452
RELATING TO PRIMA FACIE SPEED LIMITS**

The Board of Supervisors of the County
of Riverside ordains as follows:

Section 1. Section 2.2 of Ordinance No. 452, entitled "Thirty miles per hour," is hereby amended to add new subsections 22 and 23 to read as follows:

- *22. On 66th Avenue between Hammond Road and Dale Kiler Road, a total distance of approximately 0.33 miles, in the Mecca area.
- 23. On the easterly half of San Jacinto Street from a point 660' north of Stetson Avenue to a point 133' south of Luceme Drive, a total distance of approximately 0.24 miles, in the Hemet area.

Section 2. Section 2.3 of Ordinance No. 452, entitled "Thirty-Five miles per hour," is hereby amended to add new subsections 114, 115, and 116 to read as follows:

- *114. On Crest Drive between Columbia Street and Cornell Street, a total distance of approximately 0.25 miles, in the Hemet area.
- 115. On Lincoln Street between Hammond Road and 65th Avenue, a total distance of approximately 0.26 miles, in the Mecca area.
- 116. On San Jacinto Street between Thornton Avenue and a point 660' north of Stetson Avenue, a total distance of approximately 0.37 miles, in the Hemet area.

Section 3. Section 2.4 of Ordinance No. 452, entitled "Forty miles per hour," is hereby amended to add new subsections 133, 134, 135, and 136 to read as follows:

- *133. On 65th Avenue between Home Avenue and Johnson Street, a total distance of approximately 0.4 miles, in the Mecca area.
- 134. On 66th Avenue between Dale Kiler Road and Johnson Street, a total distance of approximately 0.5 miles, in the Mecca area.
- 135. On Anza Road between El Chimisal Road to the end of the road, a total distance of approximately 0.25 miles, in the Rancho Pauba area.
- 136. On Spring Street between State Highway 74 and Steele Peak Drive, a total distance of approximately 1.25 miles, in the Perris area.

Section 4. Section 2.5 of Ordinance No. 452, entitled "Forty-Five miles per hour," is hereby amended to add new subsection 154 to read as follows:

- *154. On Abelia Street between State Highway 79/Winchester Road to Washington Street, a total distance of approximately 1.5 miles, in the French Valley area.

Section 5. Section 2.6 of Ordinance No. 452, entitled "Fifty miles per hour," is hereby amended to add new subsection 71 to read as follows:

- *71. On the westerly half of Highland Springs Avenue between 17th Street to a point 690' north of 17th Street - Full Width from a point 600' north of 17th Street to Brookside Avenue, a total distance of approximately 0.25 mile, in the Beaumont area.

Section 6. Section 2.8 of Ordinance No. 452, entitled "Sixty miles per hour," is hereby amended to add new subsection 7 to read as follows:

- *7. On Varner Road between Cook Street and 38th Avenue, a total distance of approximately 1.7 miles, in the Thousand Palms area.

Section 7. Subsection 14 of Section 2.2 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 14 of Section 2.2 established a thirty miles per hour speed limit on 66th Avenue between Hammond Road and Brown Street pursuant to Ordinance No. 452.221 adopted by the Board on September 13, 2005.

Section 8. Subsection 16 of Section 2.2 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 16 of Section 2.2 established a thirty miles per hour speed limit on Lincoln Street between Hammond Road and 65th Avenue pursuant to Ordinance No. 452.221 adopted by the Board on September 13, 2005.

Section 9. Subsection 17 of Section 2.2 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 17 of Section 2.2 established a thirty miles per hour speed limit on Crest Drive between Columbia Street and Cornell Street pursuant to Ordinance No. 452.222 adopted by the Board on April 18, 2006.

Section 10. Subsection 5 of Section 2.3 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 5 of Section 2.3 established a thirty-five miles per hour speed limit on the easterly half of San Jacinto Avenue between the city limits of the City of Hemet and Stetson Avenue pursuant to Ordinance No. 452.214 adopted by the Board on February 4, 2003.

Section 11. Subsection 78 of Section 2.4 of Ordinance No. 452 is hereby repealed in its entirety. Subsection 78 of Section 2.4 established a forty miles per hour speed limit on 66th Avenue between Brown Street and Johnson Street pursuant to Ordinance No. 452.221 adopted by the Board on September 13, 2005.

Section 12. This ordinance shall take effect 30 days after its adoption.
