3. Direct the Clerk of the Board to give notice for Parcels 0264-005C, 0264-005D, and 0264-005E pursuant to Government Code Section 6061.

BACKGROUND:

The Clinton Keith Road Interchange is a high priority improvement for the Cities of Wildomar and Murrieta and adjacent county areas. The existing Clinton Keith Road/Interstate 15 interchange was constructed in 1979. The interchange is an important component of the area's traffic circulation system, and is a gateway to the City of Murrieta and the City of Wildomar. The improvements extend from west of Hidden Springs Road to east of Arya Drive.

County of Riverside (County) as lead agency in cooperation with the California Department of Transportation (Caltrans) and City of Wildomar (City), proposes to widen the overcrossing to accommodate six through lanes, dual left turn lanes, and right turn lanes approaching the ramps. The southbound exit ramp will be widened to four lanes and all ramps will be widened to three lanes. In addition to the interchange improvements, an auxiliary lane will be added to both southbound and northbound of the interchange (Project).

On May 2, 1995, by Resolution No. 95-040, the County summarily vacated Arya Drive. Attachment 1 is a location map of Arya Drive. The County's project requires a portion of vacated Arya Drive to provide access to Assessor's Parcel Number 380-240-054 vested in the names of Hose Kim and Seongmee Kim and Eun Shin (Kim/Shin). The City (functioning in the acquisition role for the Project) approached the County as the County owned vacated Arya Drive in fee simple interest. By the County quitclaiming its fee simple interest of a portion of vacated Arya Drive (identified as Parcel 0264-005A) to Kim/Shin would provide access needed and assist the City in terms of settlement with Kim/Shin. Staff recommends that the County, in furtherance of the Project, convey Parcel 0264-005A to Kim/Shin which would ultimately transfer insurance and maintenance responsibility from the County and return the portion of vacated Arya Drive to the tax rolls.

Pursuant to Government Code Section 25526, the County may transfer interests in real property or interest herein, belonging to the County which is no longer necessary for County or other public purposes, and its estimated value does not exceed \$25,000, the County may convey that real property or interest therein in the manner and upon the terms and conditions approved by the Board of Supervisors without complying with any other provisions of the Government Code. The County intends to convey its fee simple interest in real property located in the City of Wildomar, a 10,405 square foot portion of Assessor's Parcel Number 380-240-059 owned by the County by Quitclaim Deed, more particularly described on Attachment 2.

BACKGROUND: (Continued)

In addition, the County would quitclaim its fee simple interests in the remaining portion of vacated Arya Drive (identified as Parcels 0264-005C, 0264-005D, and 0264-005E) to the City of Wildomar as they are no longer located in the County's jurisdiction. Staff recommends that the County convey Parcels 0264-005C, 0264-005D, and 0264-005E to the City of Wildomar which would ultimately transfer insurance and maintenance responsibility from the County to the City. The City intends to enter into a separate agreement to convey Parcel 0264-005C as an access easement to Kim/Shin as part of the City's settlement with Kim/Shin.

Pursuant to Government Code Section 25365, a county may transfer real property or interest therein, belonging to the county to another public agency, upon the terms and conditions as are agreed upon and without complying with any other provisions of the Government Code, if the property or interest therein to be conveyed is not required for county use. The County intends to convey its fee simple interest in real property located in the City of Wildomar, Parcels 0264-005C, 0264-005D, and 0264-005E consisting of a 20,465 square foot portion of Assessor's Parcel Number 380-240-059 owned by the County by Quitclaim Deed, more particularly described on Attachment 3.

9 WHEREAS, the County of Riverside (County) is the lead agency, in cooperation
10 with the California Department of Transportation (Caltrans) and City of Wildomar (City)
11 for the Interstate 15 and Clinton Keith Road Interchange Project (Project);

12 WHEREAS, the County of Riverside (County) is the owner of certain real
13 property consisting of 30,870 square feet of Arya Drive located in the City of Wildomar,
14 has full legal title to Arya Drive (Assessor's Parcel Number 380-240-059), and has full
15 power and authority to convey all property rights described herein;


16 WHEREAS, on May 2, 1995, County summarily vacated the Arya Drive right-of-
17 way;

18 WHEREAS, one of the responsibilities of the City is to acquire all of the right of
19 way needed for the Project;

20 WHEREAS, a portion of vacated Arya Drive is needed by the City in order to
21 provide access to Assessor's Parcel Number 380-240-054 vested in the names of
22 Hose Kim and Seongmee Kim and Eun Shin (Kim/Shin) and assist the City in terms of
23 settlement with Kim/Shin;

24 WHEREAS, the remaining portion of vacated Arya Drive is located in the City
and no longer needed by the County;

WHEREAS, the conveyance of the portion of vacated Arya Drive to Kim/Shin will
serve two purposes: (1) provide access to the Kim/Shin property in furtherance of the

3 WHEREAS, the conveyance of the remaining portion of vacated Arya Drive to
4 the City would ultimately transfer insurance and maintenance responsibility from the
5 County to the City;
