None; CSTI is the only provider who can deliver highly specialized training designed specifically to address hazards facing California, CSTI also delivers the training incorporating the Standardized Emergency Management System (SEMS) and the Incident Command System (ICS) structure, which is specific to California-based responses. ICS is a critical component of California-based emergency response for fire, law, health, EMS and emergency management.

4. Extent of market search conducted:

Unique features of the supply/service being requested from this supplier, which no alternative supplier can provide: CSTI has been designed to teach California's emergency management personnel how to mitigate, prepare, and respond to disasters; other institutions are unable to offer this specific California-based training. CSTI is the only vendor approved by the State of California to provide such specialized training tailored to hazards facing California.
- 6. Reasons why my department requires these unique features and what benefit will accrue to the county: Riverside County emergency management and first responders have a long history of being in the forefront of mitigation and response because of specialized training; and would like to continue that tradition. The benefit to the County of Riverside will be enhanced knowledge of emergency management and first responder personnel during a catastrophic event which will help save lives and property, and restore life back to normal as soon as possible after a major incident. The training will be hosted by Riverside County mitigating travel cost for personnel.
