SUBJECT: In-Principle Approval for lease of new space for the Riverside County Department of Mental Health for Cultural Competency/Outreach & Engagement Program and Quality Improvement/Outpatient Program. [District 1]

RECOMMENDED MOTION: Move that the Board of Supervisors authorize in-principle, the Economic Development Agency (EDA) to seek office space to lease approximately 6,000 square feet of space for two programs, Cultural Competency/Outreach & Engagement and Quality Improvement/Outpatient.

BACKGROUND: The Riverside County Department of Mental Health (RCDMH) must relocate Cultural Competency/Outreach & Engagement Program and Quality Improvement/Outpatient Program due to program expansion and the inadequate size of the existing location. Therefore, in order to improve consumer care and provide adequate staff space, new office space in the Riverside area of Riverside County is being sought.

BACKGROUND: (Continued)

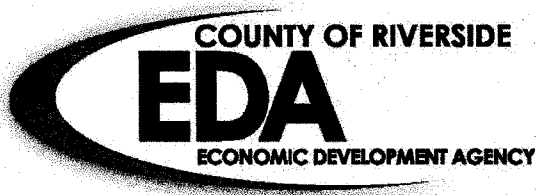
Cultural Competency/Outreach & Engagement and Quality Improvement/Outpatient Programs are both located at 3801 University Avenue, suite 400 Riverside, California 92501. The current location is at capacity and does not provide space for existing staff due to expansion of programs in the current location.

The RCDMH will need approximately 6,000 square feet of space to accommodate approximately 22 licensed professional, paraprofessional and clerical mental health staff. Below is a brief description of the programs that will be housed at the new location:

- **Cultural Competency/Outreach & Engagement:** Provides overall direction, focus and organization in the implementation of the system-wide Cultural Competency Plan that addresses the enhancement of workforce development and the ability to incorporate languages, cultures, beliefs and practices of its consumers into the services.
- **Quality Improvement/Outpatient:** Responsible for clinical oversight of all county clinics, including contract providers. QI provides a mechanism for consumers and family members to file and reach resolution on complaints and grievances. The QI works to assure that all county activities maintain high standards while adhering to mandated requirements and regulations.

FINANCIAL INFORMATION

There are sufficient funds in the RCDMH FY 12/13 budget to fund this additional space. No additional County funds are required.

Department of Mental Health Leased Space in the Riverside Area
