BACKGROUND: (Continued)

The lease agreement is a seven-year fixed rate lease with a one-year deferral arrangement. The lease payment will begin in November 2013 and is budgeted in the PSEC operating budget for FY13/14. Currently the rate is estimated at 2.94%; the final fixed rate to be determined based on the current rate available upon execution of the lease document. The county's awarded finance institute could not provide a similar viable agreement with the one year deferral.

OPINION OF COUNSEL

If for any reason the Lessee fails to enter into a Lease Agreement (containing the terms and conditions outlined herein) with the Lessor on or before November 28, 2012, the Lessee agrees to pay all costs associated with terminating the interest rate swap or any other costs the Lessor may have related to terminating this transaction.
