SUBJECT: Ratify the Agreement between County of Riverside Department of Public Health (DOPH) and Coachella Valley Association Governments (CVAG) for Public Health Nursing services to the homeless population. (Contract No: 13-023)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Agreement between the County of Riverside Department of Public Health and the Coachella Valley Association of Governments from July 1, 2012 through June 30, 2015 in the amount of \$150,000;
- 2) Approve and Direct the Purchasing Agent to sign subsequent amendments that make only ministerial changes to the Agreement not to exceed the amount stated of \$150,000;
- 3) Authorize the Chairperson to sign three (3) originals of said Agreement on behalf of the County; and
- 4) Approve and Direct the Auditor-Controller to adjust the budget as specified in Schedule A, attached.

SUBJECT: Ratify the Agreement between the County of Riverside Department of Public Health (DOPH) and Coachella Valley Association Governments (CVAG) for public health nursing services to the homeless population. (Contract No: 13-023)

BACKGROUND: Roy's Desert Resource Center (RDRC) for the homeless in North Palm Springs is administered by the Coachella Valley Association of Governments (CVAG). Currently, the facility offers shelter for men, women and children. The DOPH has been a partner with RDRC since 2009 providing nursing services to its clients.

For many homeless people, health problems become overwhelming because of prolonged lack of access to proper care. The RDRC's nursing station is a place where client's basic health care needs are initiated and provided with services to help them maintain access to care in the future. The clients at RDRC are seen by public health nurses and linked to appropriate medical resources for treatment.

CVAG was awarded a \$150,000 grant over a thirty-six (36) month period from The California Wellness Foundation (TCWF) for project support; specifically for nursing salaries, benefits, supplies and related equipment. DOPH will be responsible for nursing services and the purchase of supplies and equipment provided CVAG utilize the TCWF grant funds to reimburse DOPH for those expenses.

PERSONNEL: Pursuant to Board Policy A-30, these positions will be eliminated once funding is exhausted.

FINANCIAL DATA: The \$150,000 award is a new funding source provided by TCWF through CVAG, and it is not in the FY 2012/2013 budget.

MEMORANDUM OF UNDERSTANDING
Between The Coachella Valley Association of Governments
And The County of Riverside Department of Public Health Relative to
Grant Funds for Nursing Services at Roy's Desert Resource Center

CONTRACTOR: County of Riverside Department of Public Health (DOPH)

AGREEMENT TERM: July 1, 2012 through June 30, 2015

MAXIMUM REIMBURSABLE AMOUNT: \$150,000 (One Hundred Fifty Thousand Dollars) over 36 months

Funding Period Year 1	July 1, 2012 – June 30, 2013	\$50,000
Funding Period Year 2	July 1, 2013 – June 30, 2014	\$50,000

This Memorandum of Understanding is entered into between the Coachella Valley Association of Governments, hereinafter referred to as CVAG, and the County of Riverside's Department of Public Health, hereinafter referred to as Contractor.

WHEREAS, CVAG is the administrator of Roy's Desert Resource Center in North Palm Springs which provides services to the homeless in the Coachella Valley; and,

WHEREAS, there is currently in place a contract for Contractor to provide nursing services at Roy's Desert Resource Center, the funding source which is a grant from the Desert Health Care District ("DHCD"),

WHEREAS, CVAG applied to and received a \$150,000.00 grant from The California Wellness Foundation ("TCWF") to be used over thirty-six (36) months (starting July 1, 2012) for project support to provide health services to homeless adults and families at Roy's Desert Resource Center; specifically for nursing salaries, benefits, supplies and related equipment;

WHEREAS, the TCWF grant will serve as an additional funding source for Contractor's services;

WHEREAS, Contractor agrees to be responsible for nursing services and purchase of supplies and equipment not covered by the DHCD grant provided CVAG utilizes the TCWF grant funds to reimburse Contractor for said expenses upon submission of appropriate quarterly invoices based on the Financial Report Form as provided by TCWF to CVAG, together with




documentation of the number of clients served. The quarterly invoice shall be due to CVAG within sixty (60) days after each quarter end, except at the end of the fourth quarter of each year when the quarterly invoice will be due to CVAG by July 25. Awareness of communicable disease control methods shall be met by providing a minimum of six (6) disease prevention trainings to residents. Training of shelter staff will be coordinated through CVAG. All required documentation shall be provided to CVAG as part of Contractor's monthly report to the CVAG Homelessness Committee. Utilizing the documentation provided by Contractor, CVAG shall prepare and present two annual reports to TCWF: a Narrative Progress Report and a Financial Progress Report. These two reports are due to TCWF by the 31st of July for each of the three years starting July 31, 2013; and,


WHEREAS, the TCWF grant funds for each of the three funding periods are to be expended annually by end of day, June 30th, 2013; June 30, 2014; and, June 30, 2015, respectively, with any unused portion of the grant funds to be returned at that time to TCWF.

THEREFORE, CVAG and the Contractor are entering into this Memorandum of Understanding to memorialize their agreement for the expenditure and use of the TCWF grant funds as set out above.

The undersigned, as authorized representatives of CVAG and Contractor, respectively certify the establishment of this MOU to be effective July 1, 2012.
