RECOMMENDED MOTION: Move that the Board of Supervisors:

- 1) Authorize the Chairman of the Board to approve the Sole Source procurement of GlideScope GVL Cobalt System from Verathon Medical;
- 2) Authorize the Purchasing Agent to renew the maintenance agreement for up to three (3) additional years in 12-month increments, not to exceed \$13,842.00 annually, subject to 5% CPI price increase;
3. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to sign amendments that do not change the substantive terms of the agreement for up to 10 percent (10%) of the maximum contract amount.
