RECOMMENDED MOTION: (continued)

- 2) Approve the Tenth Amendment to the Agreement with the American Lung Association in California (ALAC) for the monitoring of statewide TB prevention and control activities to extend the performance period from July 1, 2012 through December 31, 2012 to July 1, 2012 through June 30, 2013 in the amount of \$148,537 as is required by the State grant; and
- 3) Authorize the Chairman of the Board to sign three (3) original "Acceptance Award" letters and four (4) original copies of the Amendment with ALAC; and
- 4) Authorize the Director of Public Health to sign future contract amendments limited to the shifting of funds between budgetary line items as needed to facilitate the delivery of program services. Any amendments which would alter the original approved total grant award or change any given fiscal year's revenues or modify the lifetime of the grant will be brought to the Board of Supervisors for approval.

BACKGROUND:

Tuberculosis (TB) continues to be a significant public health problem in California. The CDPH has awarded funds for TB prevention and control activities, which includes funding for American Lung Association in California (ALAC).

The contract with ALAC, TB education and prevention, was approved on January 11, 2000 and expired after seven amendments. A new contract #04-002 with ALAC for the Local Assistance Funding was approved by the Board on October 7, 2003, agenda item 3.15 for Fiscal Year 03/04 and has been renewed nine times. This Tenth amendment to the agreement is to extend the period of performance from July 1, 2012 through December 31, 2012 to July 1, 2012 through June 30, 2013 in the amount of \$148,537.

The total award amount is of \$161,499 which was included in Fiscal Year 12/13 budget therefore no budget adjustment is requested. Of this amount, \$148,537 is state funding for ALAC to support tuberculosis (TB) prevention and control activities, and \$12,962 is for County of Riverside Administrative costs.

TENTH AMENDMENT TO THE AGREEMENT
WITH
AMERICAN LUNG ASSOCIATION

(TB education and Prevention)

That certain Agreement between the COUNTY OF RIVERSIDE ("COUNTY") and American Lung Association of California ("CONTRACTOR"), approved on October 07, 2003 Item 3.15, amended for the first time on October 19, 2004, Item 3.13, amended for the second time on October 4, 2005, Item 3.8, amended for the third time on August 29, 2006, Item 3.25, amended for the fourth time on February 26, 2008, agenda item 3.22, amended for the fifth time on December 23, 2008, item 3.9, amended for the eighth time on October 18, 2011, amended for the ninth time on July 12, 2012, is hereby amended for the tenth time as follows, effective December 1, 2012:

1. To extend the period of performance from July 1, 2012 through December 31, 2012 to July 1, 2012 through June 30, 2013.
2. To establish the amount of compensation for one hundred forty-eight thousand, five hundred thirty-seven dollars (\$148,537), including all expenses.
3. All other terms and conditions of this Agreement are to remain unchanged.


