With this important role, comes the responsibility to raise issues, recommend changes, and advocate for those changes. Effective volunteer leaders in partnership with government and community liaisons will continue to make a difference for seniors and older adults with disabilities in Riverside County.*

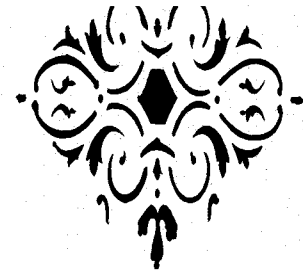
# ADVOCACY

*The Advisory Council is designated by the Older Californian's Act and the Older Americans Resources Act as an advocacy body. As liaisons to their communities, Council Members have the responsibility to raise issues, recommend changes, and advocate for those changes. Many ongoing, emerging, or large scale advocacy issues or initiatives are addressed locally with the Riverside County Executive Office, Board of Supervisors, Office on Aging or through the County Legislative Platform. Without Council Leadership, opportunities to improve the quality of life of seniors and older adults with disabilities would be fewer and negative attitudes of ageism would be stronger.*

- Position Statement to sustain current levels of funding for RSVP program.
- Position Statement to transition the Senior Employment Program from the Department of Labor to Administration on Aging.
- Position Statement in opposition of the Adult Day Health Care (ADHC) elimination effective December 1, 2011.
- Coordinated a Fit after 50 program in Blythe and rallied volunteers to join in the start up of the program at the Blythe Community Center which has grown to more than 30 enrollees and have had many reports of improvements in the physical condition of the attendees.
- Participated in a Senior Center Forum in Los Angeles that was designed to bring together senior centers in California to strategize methods of center program sustainability and advocacy for senior services.
- Took a position that recommended the building of housing units in Meniffee designed to home seniors and adults with mental illness. An article was written in The Californian Newspaper from the Council publicly supporting the project.
- Supported the efforts to explore the possibility of a Program of All-Inclusive Care of the Elderly (PACE) in Riverside County.
- Council supported the Office on Aging 2012 State Legislative Platform which advocated for continued funding of the Multipurpose Senior Services Program (MSSP) and the 2012 Federal Legislative Platform advocated for Older Americans Act Reauthorization and Appropriation.

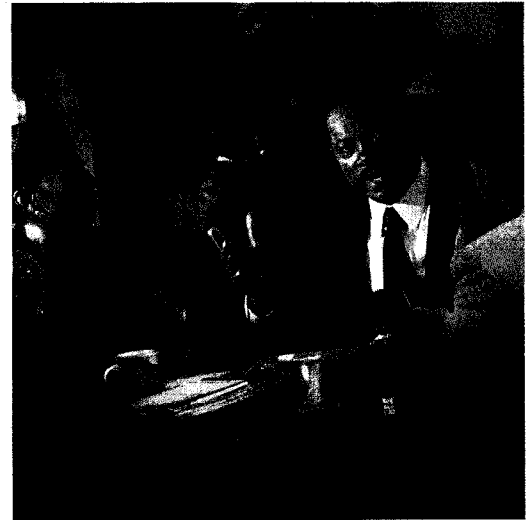
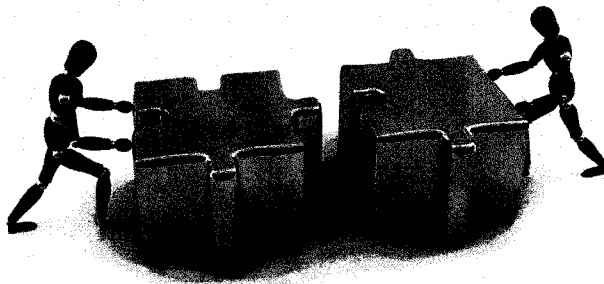
## EXECUTIVE COMMITTEE GLORIA SANCHEZ, CHAIR

*Changes to the Council's bylaws are reviewed annually.*

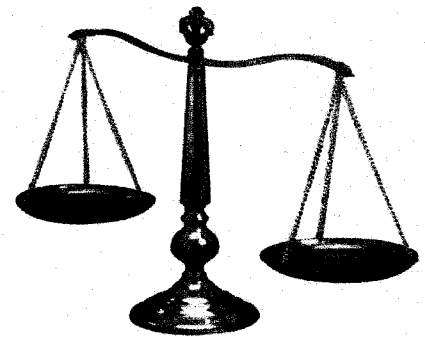
Convened by Parliamentarian to meet annually and as needed to review the Council Bylaws.

Changes to Bylaws made to state that a quorum of members will not include members on a formal leave of absence.

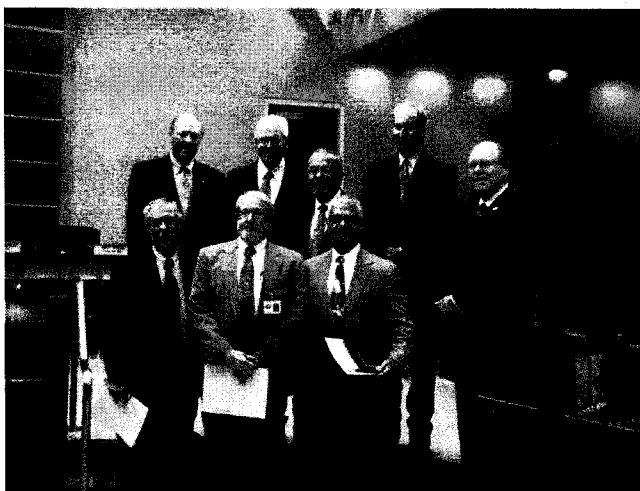

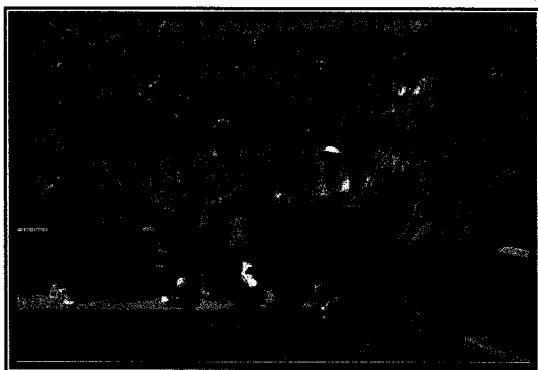

The Committee designed a flyer and a drop box and the Council promoted the program, delivered boxes and an informational flyer to different locations, and collected the donated cell phones.

Presented the Marion Ashley Community Center with a Focal Point on Aging plaque and a proclamation from the Board of Supervisors recognizing them as a community resource for seniors.

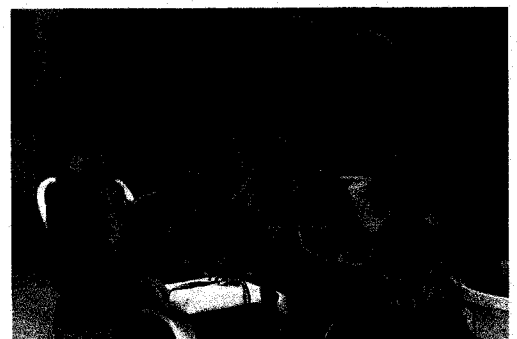
Distribution of Grandparents Raising Grandchildren Resource and Information guide to Council, community partners, other departments, and elected officials.

Programs held in Corona, Cathedral City and Indio called "Fathers Speaking Out" which included topics such as teaching values to children, discipline vs. punishment, and Jugando Con Sus Hijos (playing with your children).

Grandparents Raising Grandchildren participated in community outreach activities: Mead Valley Health and Safety Fair sponsored by Supervisor Buster, Celebrate Recovery in Indian Wells, Senior Health fair in San Jacinto. Presentation to Faith in Action Committee of Banning, Moreno Valley Holiday Fair, Inland Association for Continuity of Care, Pass Collaborative, Lions Club of Corona, Southwest and Mid-County Child Care Consortium groups, forum for grandparents raising grandchildren and their teen/preteen grandchildren on critical issues raising teens, substance abuse, social networking, sexting, and cyber bullying, and preparing teens for college or career after age 18. Hosted a summit focusing on youth as caregiver to raising awareness among educators and other professionals who provide service to youth about the prevalence of child caregivers, identifying them and developing an action plan for providing them support for their role as caregiver.

Holiday gift donations were distributed to the Grandparents Raising Grandchildren participants.

Grandparents Raising Grandchildren Task Force Public Relations Committee has proposed a new initiative to partner with DPSS Independent Living Plan Program to develop similar services and resources for youth outside of the foster care system to better assist grandparents with preparing grandchildren to be independent adults.

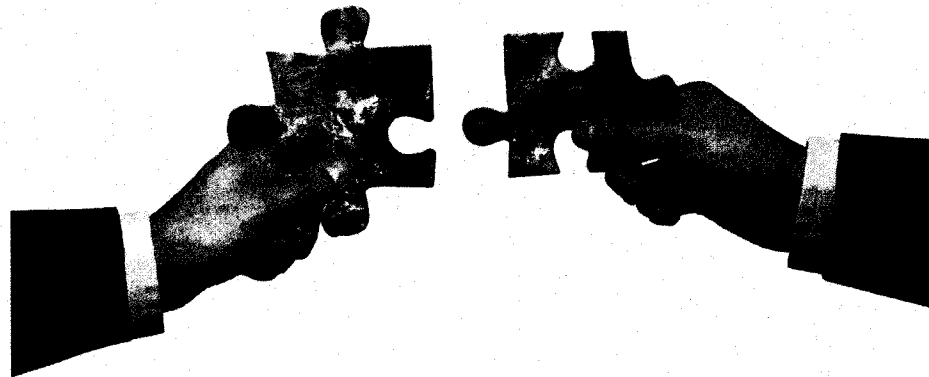

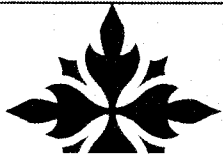

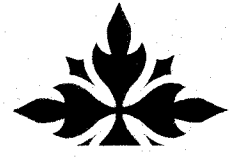

# LIAISONS



**California Senior Legislature:** Erwin Fromm, Leo Sullivan, Ann Kasper were elected to the California Senior Legislature, a volunteer body whose primary mission is to gather ideas for legislation at the state and federal levels, craft the ideas into formal proposals, prioritize the proposals, present them to members of the Legislature or the Congress, and advocate for laws implementing the ideas.

**Veterans:** Council members Vee Maiden and Alice Chandler are actively involved in local and state veterans groups, including the VFW, American Legion, and Riverside County Veterans Services Advisory Board. Monthly reports included the fatalities and casualties of the current war, local events that involved veterans or veterans services, and fundraising activities for local veterans and their families.

**Foundation on Aging:** Gloria Sanchez is the Chair of the Foundation on Aging which was developed to raise funds to provide grants to enhance senior programs and services. The Foundation Board successfully hosted their first annual golf tournament at Menifee Lakes Golf Course. Gloria Sanchez and Supervisor Stone attended the Office on Aging All Staff meeting to recognize the staff that volunteered their time at the Golf Tournament. A new website, letterhead, logo, and business cards were developed.

**In Home Supportive Services (IHSS):** Jerry Corrales served as Chair of the IHSS Advisory Council. The Council serves as an advisory board to the IHSS Program. The focus of 11-12 activities was increasing membership to include more consumers.

**Older Adults System of Care:** Gloria Sanchez has served on this committee for a number of years. The committee focus is on senior mental health services in Riverside County.

**Triple A Council of California (TACC):** Erwin Fromm, Advisory Council Member, attended Triple A Council of California (TACC) meetings on behalf of Gloria Sanchez, Advisory Council chair. The mission of TACC is to promote communication and collaboration among local advisory councils and key/state partners to education through the exchange of information, ideas, trends, and models of service delivery; advocate on issues of concern in local/state planning processes; and strengthen the advocacy effectiveness and leadership skills of local Advisory Council's.

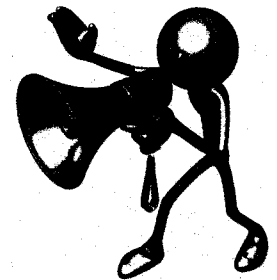

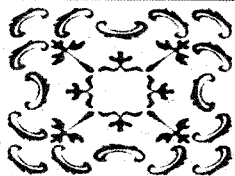


# PRESENTATIONS

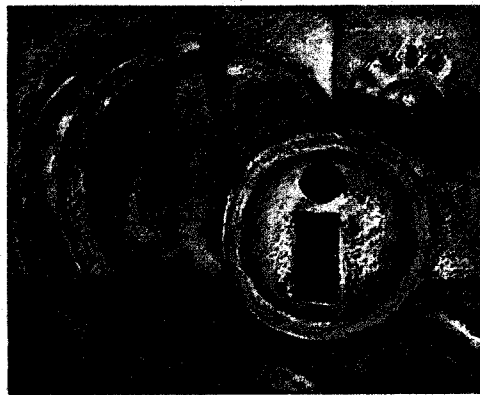

The Council is charged with the responsibility to identify priority legislative and regulatory issues, consider population trends, unmet needs, and emerging issues to use in the development of the plan. In addition, the Council focuses on the outcomes of the Plan goals and on performance measures for programs and services to gain a clearer understanding of how aging services and funds are affecting the lives of seniors and older adults with disabilities. Based on the outcomes, the Council recommends strategies and advocates for changes to better serve the community.*

- Focus group hosted at September Advisory Council meeting which included an overview of the Strategic Plan on Aging process followed by a survey of attendees on their priorities.
- Conducted a survey of Council to understand and address the needs of older adults.
- Council members assisted with distributing Strategic Plan surveys in different areas of the County.
- Assisted the Office on Aging in hosting 17 focus groups across the County and three web based surveys.
- Strategic Plan on Aging Objectives that were the responsibility of the Advisory Council were reviewed.
- Selected "Focusing on a Healthy Tomorrow" as the name of the 2012-16 Strategic Plan on Aging.
- Hosted a Strategic Plan on Aging Public Hearing at the February Advisory Council meeting.
- Set priorities for the Strategic Plan on Aging goals and objectives.
