SUBJECT: Authorization for Treasurer-Tax Collector to Accept and Release Surety Bonds

RECOMMENDED MOTION: That the Board of Supervisors approve and adopt Resolution 2012-227 to delegate the duty to accept and release surety bonds for property taxes and special assessments from the Clerk of the Board to the Treasurer-Tax Collector.

BACKGROUND: Government Code 66492 requires that, prior to the filing of a final map or parcel map, applicants obtain a certificate prepared by the Treasurer-Tax Collector showing that all local taxes and special assessments now due and payable have been paid.

Pursuant to Government Code 66493, the applicant is then required to file with the Clerk of the Board security conditioned upon payment of all local taxes and special assessments now a lien, but not yet payable. In order to do so, the applicant must first petition the Treasurer-Tax Collector to prepare an estimate of those taxes now a lien but not yet due.

Background (Continued):

After the determination of said amount, if the applicant secures a surety bond as security, the bond must be filed with the Clerk of the Board. At a later date when it has been determined that the lien requiring security has been satisfied, the Treasurer-Tax Collector must notify the Clerk of the Board to release the surety bond.

Government Code 66494 allows the Board of Supervisors to delegate the duties of the Clerk of the Board to any other County officer. Both the Treasurer and Clerk of the Board find that the process could be made more cost-effective and customer friendly if the Treasurer assumed full responsibility for this process.

RESOLUTION BY THE BOARD OF SUPERVISORS OF RIVERSIDE COUNTY
TO DELEGATE AUTHORITY TO RELEASE SURETY BONDS TO TREASURER-
TAX COLLECTOR

WHEREAS, Section 66494.1 of the Government Code empowers the Board of Supervisors in each county to delegate the duty to accept and release security conditioned upon payment of Property Taxes and Assessments or Surety Bonds and;

WHEREAS, the duty to accept and release Surety Bonds is more efficiently handled by the Treasurer-Tax Collector and;

NOW THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Riverside does hereby delegate the duty to accept and release security conditioned upon payment of Property Taxes and Assessments or Surety Bonds to the Treasurer-Tax Collector, effective 12/182012.
