**BACKGROUND:**

The Board approved a contract with Jeremy Harris Construction, in the amount of \$60,935.06 as Agenda Item Number 11.5 on September 11, 2012.

Board authorization of the contract item adjustment is necessary to authorize payment for extra work and costs associated with the change of existing field conditions resulting in a change of quantities.

Section II, Article 2.07A states that Board authorization should be obtained if a change due to extra work exceeds ten percent (10%) of the original contract. The contract item adjustments in the amount of \$11,617.50 will increase the total construction cost of the project to \$72,552.56, which is nineteen percent (19%) over the original contract amount.

The District and the Contractor agree that the retention funds still held by the District shall be properly paid to the Contractor approximately 45 days following recordation of the Notice of Completion (assuming no stop notices are filed).

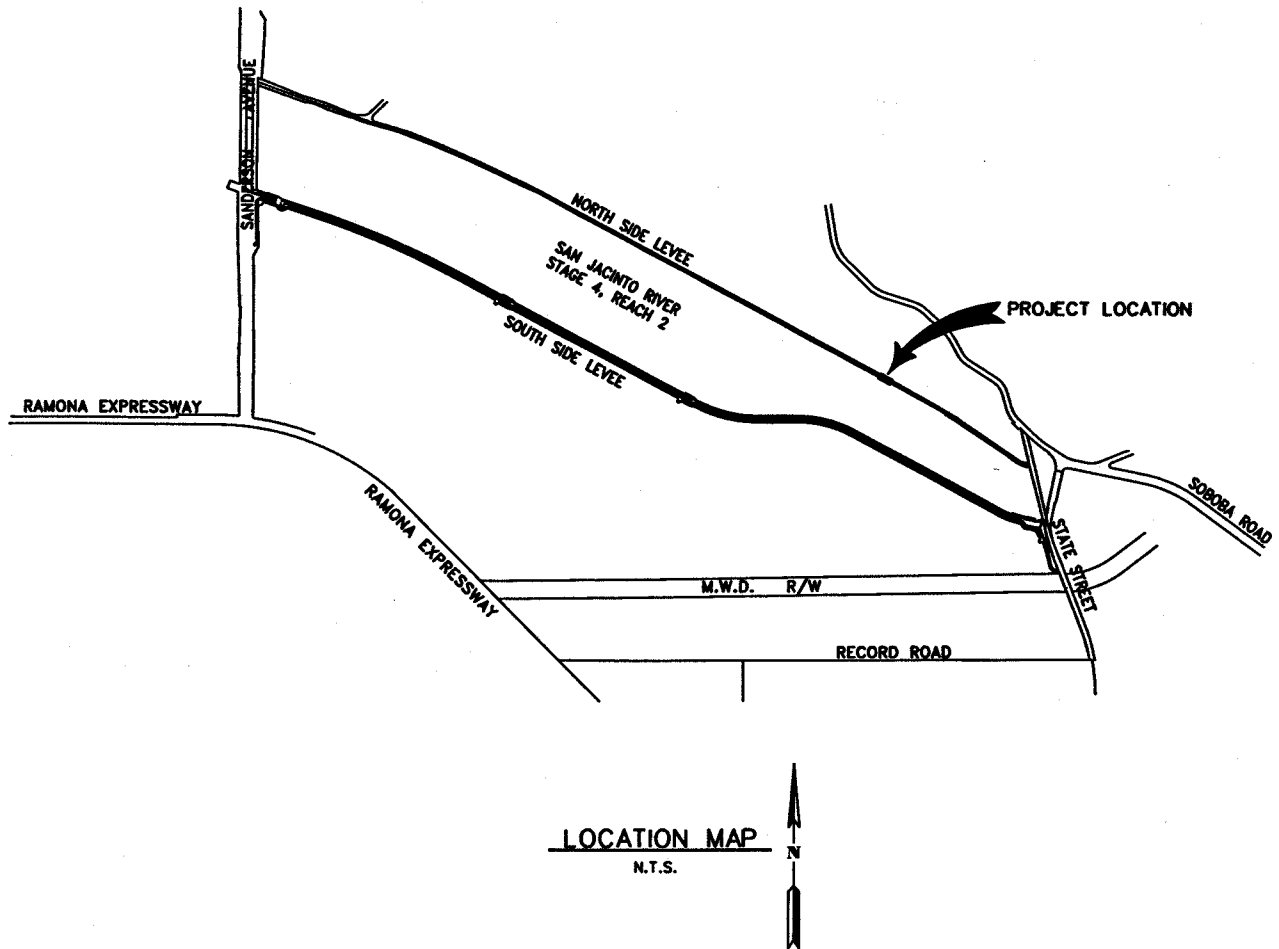
Final inspection of the above referenced project was made, and the project was found to be complete according to plans and specifications. A brief project description and location map are attached.

**FINANCIAL:**

Sufficient funds are available in the District's FY 2012-2013 Zone 4 budget for this contract increase of \$11,617.50 for this project.


