SUBJECT: Acceptance of a California Office of Traffic Safety Grant award for the Riverside County District Attorney's Office DUI with Death and Injury Vertical Prosecution Program and Adoption of Resolution 2012-022.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Ratify and approve acceptance of a grant award (Grant Agreement attached) from the California Office of Traffic Safety ("OTS") in the amount of \$360,000 for the grant period October 1, 2011 through September 30, 2012.
2. Approve and direct the Auditor-Controller to make the budget adjustments as shown on Schedule A, attached.
3. Adopt Resolution 2012-022 authorizing the District Attorney and/or his designee to sign the Grant Agreement on behalf of the Board.

BACKGROUND: OTS has made grant funding available to the County of Riverside District Attorney's Office for the implementation of a DUI with Death and Injury Vertical Prosecution Program in the southwest region of Riverside County.

BACKGROUND CONTINUED:

The creation of the DUI with Death and Injury Vertical Prosecution Unit will provide a central location throughout the southwest region of the county for law enforcement, victims, and the community.

The DUI with Death and Injury Vertical Prosecution Program will consist of a Deputy District Attorney and a Senior District Attorney Investigator. This specialized team will investigate and vertically prosecute all felony DUI with injury and DUI related vehicular homicide cases in the Southwest Riverside County region. Vertical prosecution is shown to improve conviction rates, reduce victim trauma, and provide more consistent, appropriate sentencing.

Another component of the specialized team will be to coordinate and participate in DUI prevention and awareness activities to schools and local law enforcement agencies; and to participate in campaigns such as MADD and Every 15 Minutes.

An adjustment of \$271,051 is required for a pro-rated amount of the grant award as nine months of the grant period is in Fiscal Year 2011-2012 (See Attachment A). The remaining portion (\$88,949) of the award will be included in the budget process for FY2012-2013.

The grant award and resolution have been reviewed and approved as to form by County Counsel.

1. This Agreement is entered into between the Office of Traffic Safety and the County of Riverside District Attorney Office.
2. Grant Period: 10/01/2011 to 09/30/2012
3. Federal Funds allocated under this Agreement shall not exceed: \$360,000.00
4. Grant Title: DUI with Death and Injury Vertical Prosecution

Grant Description: The Riverside County DA'S Office proposes to establish a new DUI with Death and Injury Vertical Prosecution Program in the southwest (mid-county) region of Riverside County.

The DUI with Death and Injury Vertical Prosecution Program will consist of a Deputy District Attorney and a Senior District Attorney Investigator. This specialized team will investigate and vertically prosecute all felony DUI with injury and DUI related vehicular homicide cases in the Southwest Riverside County region. Another component of the specialized team will be to coordinate and participate in DUI prevention and awareness activities to schools and local law enforcement agencies; and to participate in campaigns such as MADD and Every 15 Minutes.
