BACKGROUND:

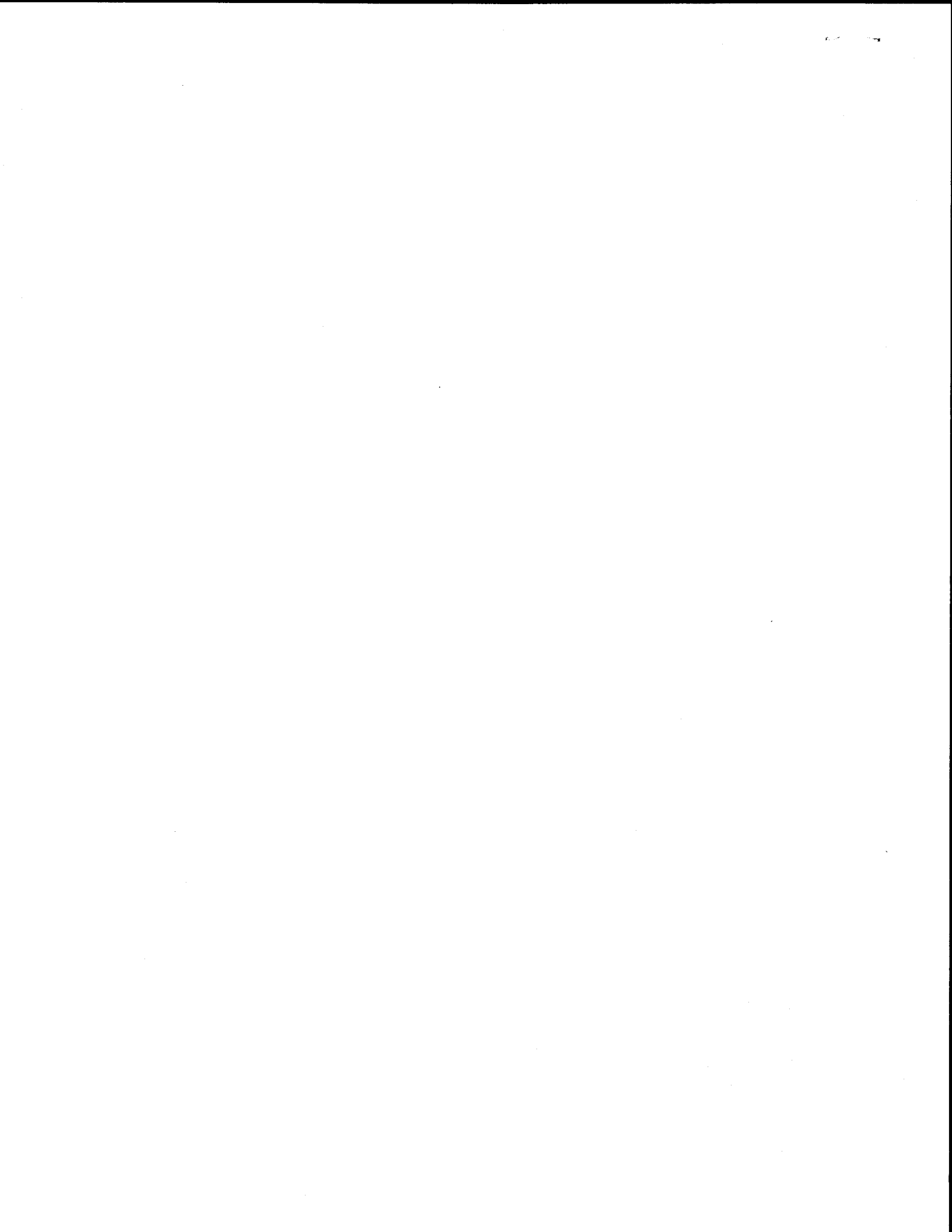
On October 19, 2010, the Board of Supervisors approved the construction agreement between Datatel Wiring Products Inc., and the County of Riverside for the Inpatient Treatment Facility Security Cameras and Monitors Project.

The project was inspected and found to comply with all contract requirements. This Board action will release \$5,798, which is 5% of the total contract, and the remaining retention funds of \$5,797 to Datatel Wiring Products Inc. The sum of these two amounts is \$11,595.

All costs associated with this agreement will be fully funded by RCRMC Operating Funds, thus no net county cost will be incurred as a result of this agreement.



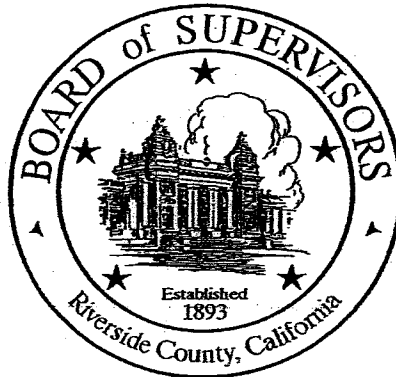
