SUBJECT: Acceptance of Blue Shield of California Foundation Low Income Health Program Implementation Grant Award

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Accept the Blue Shield of California Foundation Low Income Health Program Implementation grant award in the amount of \$100,000 to support Riverside County HealthCare operations.

BACKGROUND:

Riverside County will be implementing its Low Income Health Program, known as Riverside County HealthCare (RCHC), in January 2012. A component of California's "Bridge to Reform" Section 1115 Medicaid Waiver, this program will serve Riverside County residents between the ages of 19-64 with incomes up to 133% of the Federal Poverty Level who are not currently eligible for Medi-Cal or Healthy Families.

BACKGROUND (cont.)

To ensure the successful implementation of the RCHC program, information technology infrastructure is needed in key areas to support the program's operations. This grant will support the purchase and implementation of an electronic, web-based patient referral management system to coordinate specialty care referrals and out-of-network service authorizations for RCHC enrollees. This new system will assist RCHC in efficiently managing patient referrals for specialty care services that will ensure timely access to services. It will also help track the costs associated with authorized out-of-network services.

The grant will also fund the development of selected electronic interfaces that will allow the referral management system to transmit and receive information from other computer information systems that support RCHC operations. One example is an interface that will connect the referral management system to Riverside County Regional Medical Center's clinic scheduling system to facilitate the scheduling of a patient's specialty care appointment at the time the referral authorization is approved. In addition, funding will be used to retain consultants who will provide project management services and assistance in the building of these electronic interfaces.
