BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 348 , 541 and 725 authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Multiple Notices of Violation and Administrative Citations were issued over an extensive period of time, in an effort to bring the property into compliance. With regard to Case No. CV05-6390, on or about Oct. 10, 2006, the violations were corrected (accumulated rubbish and excessive outside storage) and the case was closed. On or about September 17, 2009, Case No. CV07-4734, the violations were removed (construction without permits - storage shed and play house) and the case was closed. Additionally, on or about Oct. 21, 2009, Case No. CV07-4741, the violation was corrected (excessive outside storage) and the case was closed.

The Notice of Hearing re Statement of Abatement Costs has been posted on the property and mailed to the property owner and all interested parties, as required by law. Copies of all relevant notices issued in this matter together with proof of service and posting have been separately filed with the Clerk of the Board and are made a part of the record herein, pursuant to Riverside County Ordinance 725.
