I would like to bring this issue to Roy Bleckert, the Zone Commissioner's attention and put this on the agenda. FOR JAN-31-2012

On Nov 7, 2011 I delivered to Supervisor Ashley, Chairman of the Flood Control Board 7 documents. No. 1- Report May 27, 2008 from U.S. Corps of Eng. Stating Bautista Creek Channel could fail because of modifications of side drainage levees. No. 2- Contract for \$157,000 9/20/88 for modification of side drainage levees. No. 3- a certified letter from the U.S. Corps of Eng. Dated 7/1/96 stating no permits were ever issued to modify the levees or place fill in the public road. No. 4. - Reports to the U.S. Corps of Eng. From Warren Williams that have been mistated dating from 2010 back to 1986. All reports state that Bautista Creek improvements are performing as designed and constructed. This is false.

Supervisor Stone is Vice Chair of the Board. One must remember he paid \$26000 in fines for corruption cases to the attorney General. In one case the Pharmacy Board made 20 accusations of improperly labeled drugs. - dishonesty, fraud, deceit and corruption. No. 5- Agenda 10.3, Oct 3<sup>rd</sup>, 1995. In agenda 10.3 Riverside County Flood Control Director Kenneth Edwards recommended that the Board approve resolution no. F95-50, authorization to convey 4 non exclusive easements for ingress and egress purposes over district owned land. Justification- side channel modification has landlocked 4 property owners and these easements will provide new unobstructed access to the property owners. Supervisor Buster and Supervisor Tavaglione voted yes. Supervisor Tavaglione signed the easements. Four easements were received by Kenneth Edwards for recording 10/25/95. Document No. 6-7- Two letters dated Dec 25<sup>th</sup>, 2010 and May 4<sup>th</sup>, 2011 from Riverside County flood Control Assistant Chief Engineer, Steve Thomas to Robert Mabee stating his easement deed and three other easement deeds to the other property owners were never recorded and can not be found. I ask Chairman Ashley to record the missing deeds and provide the property owners a letter of apology for being 15 years late, and remove the fill over the levee that blocks the public road and restore the levee to the original design as recommended by the U.S. Corps of Eng. to insure that there will be no loss of life or property in the future.
