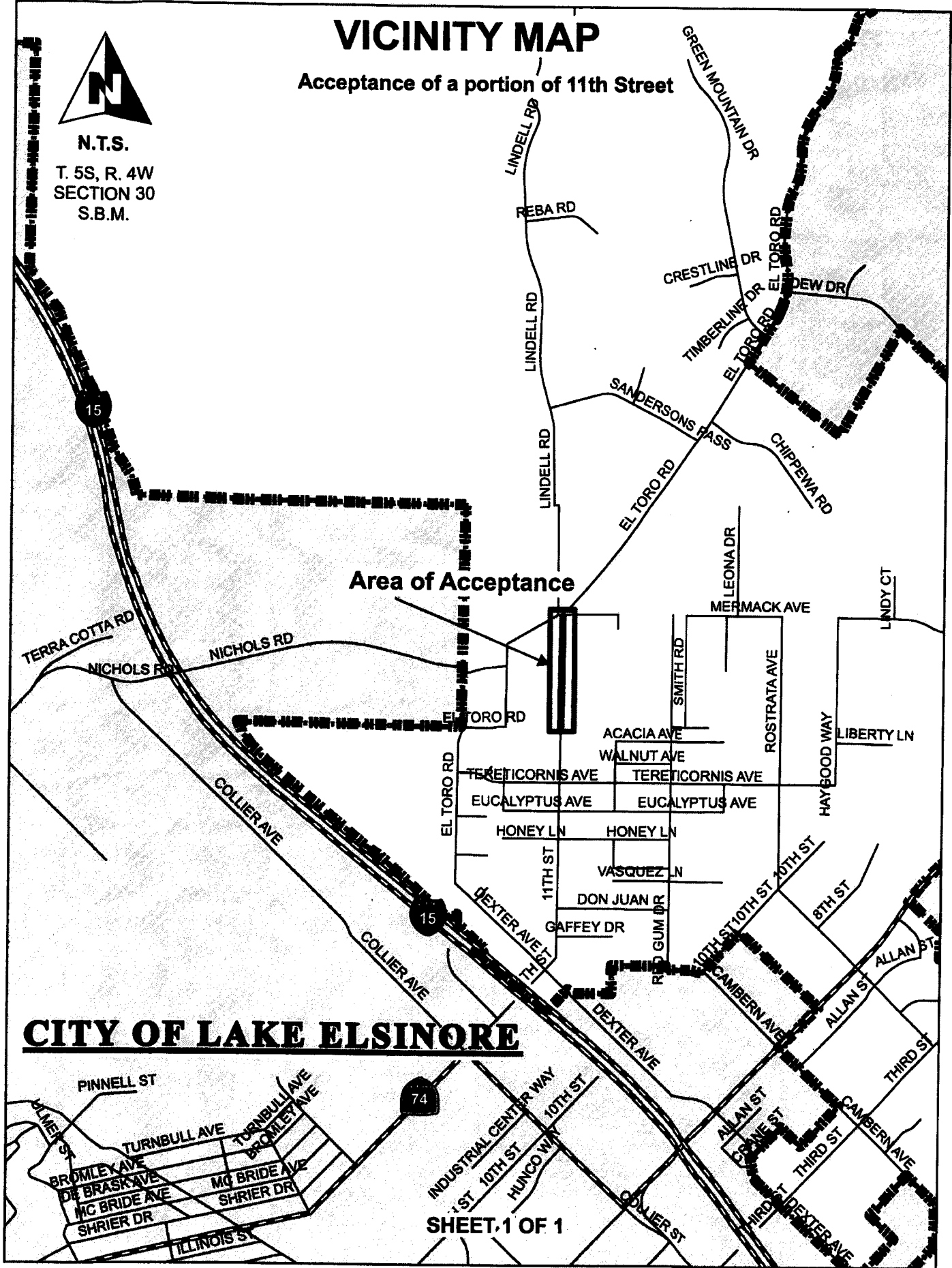
VICINITY MAP
