The information provided below is in support of the District requesting approval for a sole source. Outside of a duly declared emergency, the time to develop a statement of work or specifications is not in itself justification for sole source.

- Supply/Service being requested: To provide the District with a fully updated and integrated FMS Wireless Automated Fueling System.
- 2. Supplier being requested: The preferred vendor for providing this fueling system is "AssetWorks". AssetWorks is also the supplier of the District's existing fleet management system which has been in use for over 10 years.
- 3. Alternative suppliers that can or might be able to provide supply/service: AssetWorks FuelFocus FMS system is not sold through distributors or resellers as most conventional fuel management systems are. The sole source for a fully integrated AssetWorks Fuel Management System, along with any and all related replacement parts is to purchase it directly from AssetWorks as quoted.
- 4. Extent of market search conducted: We have researched several other fuel systems on the market, but none of them will integrate directly into our existing FleetFocus FA Fleet Maintenance System. Our goal is to eliminate multiple software programs and consolidate to one maintenance/fuel management system.
- 5. Unique features of the supply/service being requested from this supplier, which no alternative supplier can provide: The FleetFuel FMS Wireless Fueling System as quoted to the District is a proprietary piece of hardware and software that has direct integration into our existing FleetFocus FA Fleet Maintenance Software System. This direct integration will facilitate the installation and implementation process. In addition, the likelihood of having system issues in the future due to incompatible modules is minimized because we are adding a new fuel feature to an already existing fleet management system.

- 6. Reasons why my department requires these unique features and what benefit will accrue to the county: Due to the complexity of our existing FleetFocus FA Fleet Maintenance Software System and the potential of data loss should other vendors try to integrate their system with the FleetFocus database, AssetWorks is the logical choice. AssetWorks developed their own proprietary fuel management system in 1985. This system allows users the ability to control and capture all of their fuel and fluid dispensing directly into FleetFocus FA without the need of maintaining separate databases and the inherent problems associated with using multiple databases.
- 7. Price Reasonableness including purchase price and any ongoing maintenance or ancillary costs from the supplier: The price for a complete and integrated fuel system, along with a one year maintenance contract and service support is \$141,671.85 plus tax.
- 8. Does moving forward on this product or service further obligate the county to future similar contractual arrangements or any ongoing costs affiliated with this sole source? (Maintenance, support, or upgrades, if so, please explain). The new fuel system will require periodic maintenance and upgrades. Also to be included would be new installations of fuel communication equipment on recently purchased vehicles and equipment.
