5. Re-appoint Jim Thompson, 4000 Pierce Street, Space 88, Riverside, CA 92503 (951) 751-7775, to a new 2-year term to expire June 30, 2014.

Mr. Mizak is an Air Force veteran, served in Vietnam, and was nominated for VAC membership by VFW Post 9223, Riverside, CA. He has been active in the VFW, the American Legion and the RNC Memorial Honor Detail.

Mr. Hagen is a Navy veteran, also served in Vietnam, and was nominated by AMVETS Post 66, Rancho Mirage, CA. He has been active in the Navy League and the AMVETS-Express transportation service, transporting veterans from the Coachella Valley to the Loma Linda VA Medical Center.

Ms. Powell retired from the military as a Chief Master Sergeant after serving 38 years in the USAF, Air Force Reserves and the California Air National Guard. She has an extensive background in the medical and aero-space industries combining management, quality control and training skills and experience.

Mr. Paul Adcock is an Army veteran; he served in Vietnam and was nominated by VFW Post 9223 (Riverside). He is the Post Service Officer, and is very active in Veteran Programs.

Mr. Jim Thompson is an Air Force veteran; he was nominated by American Legion Post 289 (Riverside). Jim volunteers at the VA Hospital and helps with the Troop picnic at MARCH AFB.

At the VAC's regular April 3, 2012 meeting, the district representatives present voted to recommend to the Board of Supervisors that Mr. Mizak, Mr. Hagen, Ms. Powell, Mr. Adcock and Mr. Thompson be re-appointed to a new 2-year term.
