

SUBJECT: Approve Sole Source Service Agreement with the State of California, California Emergency Management Agency (CALEMA), California Specialized Training Institute (CSTI).

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve sole source training service from CALEMA, CSTI not to exceed \$55,000 without seeking competitive bids,
2. Authorize Purchasing Agent, in accordance with Ordinance No. 459, to award the contract on behalf of the County.

BACKGROUND: Riverside County Fire Department Office of Emergency Services (FIRE OES) has secured grant funds from the State Homeland Security Grant Program and Emergency Management Performance Grant to obtain State of California approved Disaster Preparedness training for the County.



As part of the FIRE OES mission, we are responsible for disaster mitigation, preparation, response and recovery. This class will enhance the knowledge of OES staff members as well as members of the Operational Area to enable us to coordinate and successfully host disaster excises, coordinate disaster mitigation and disaster recovery efforts on behalf of the County.

PRICE REASONABLENESS:

Training classes for Disaster Preparedness and Mitigation are very specific in nature and CALEMA, CSTI is the only vendor approved by the State of California to provide such specialized training and is tailored directly to the hazards facing California.

If Fire OES were to send eleven students to CALEMA, CSTI in San Luis Obispo total cost would be approximately \$22, 000. Bringing the CSTI courses to the County of Riverside would allow the opportunity to train thirty-five to forty individuals per class without incurring the costs for hotel accommodations, per diem charges, and travel expense claims normally associated when sending employees to the vendor's location for training.

The below information is provided in support of my Department requesting approval for a sole source. Outside of a duly declared emergency, the time to develop a statement of work or specifications is not in itself justification for sole source.

1. Supply/Service being requested:

Training and teaching instructor services from California Specialized Training Institute (CSTI) who provide California-based emergency management training in areas of mitigation, preparation, response and recovery. Specific training being requested; Introduction to Emergency Management: Earthquake.

3. Alternative suppliers that can or might be able to provide supply/service:

CSTI is the only provider who can deliver highly specialized training designed specifically to address hazards facing California, CSTI also delivers the training incorporating the Standardized Emergency Management System (SEMS) and the Incident Command System (ICS) structure, which is specific to California-based responses. ICS is a critical component of California-based emergency response for fire, law, health, EMS and emergency management.

4. Extent of market search conducted:

As a branch of the Governor's California Emergency Management Agency, CSTI was developed specifically for the purpose of offering California-based emergency management training. FIRE-OES have worked with many other industry professional training institutions across the United States for many years and none are able to offer this specialized training. Specifically, Texas Engineering Extension Services (TEEX), Wildan Homeland Solutions and independent consultant/trainers are amount a few who the department has contacted regarding these specialized trainings and none are as specific as CSTI.

5. Unique features of the supply/service being requested from this supplier, which no alternative supplier can provide:

CSTI has been designed to teach California's emergency management personnel how to mitigate, prepare, and respond to disasters; other institutions are unable to offer this California-based specialized training.

6. Reasons why my department requires these unique features and what benefit will accrue to the county:

Riverside County emergency management and first responders have a long history of being in the forefront of mitigation and response because of specialized training; and would like to continue that tradition. The benefit to the County of Riverside will be enhanced knowledge of emergency management and first responder personnel during a catastrophic event which will help save lives and property, and restore life back to normal as soon as possible after a major incident. The training will be hosted by Riverside County mitigating travel costs for personnel who, due to budget shortages, may have not otherwise had the opportunity to partake in this much needed training.

The training class, Introduction to Emergency Management: Earthquake are very specific in nature and CALEMA, CSTI is the only vendor approved by the State of California to provide such specialized training and is tailored directly to the hazards facing California.
