

SUBJECT: Amendment to the Professional Services Agreement for Riverside County Regional Medical Center's Detention Health Physicians

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Ratify and authorize the Purchasing Agent to sign the Contract Agreements with Nerizza Andrada, M.D. and Lydia David, M.D. without securing competitive bids; in accordance with Board Policy A-18 and Ordinance 459.4 to provide physician services for RCRMC's Detention Health effective July 1, 2010 through June 30, 2011, with the option to renew annually for four additional years.
2. Approve and authorize the Chairman to sign the attached amendments with Nerizza Andrada, M.D. and Lydia David, M.D., in an aggregate amount not to exceed \$109,000 annually,
3. Authorize the Purchasing Agent to move dollars between these agreements as needs dictate as long as the aggregate amount does not exceed the annual amount, and;

RECOMMENDED MOTION (continued):

4. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise renewal options, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation not to exceed ten percent above the annual aggregate amount of the contract.

BACKGROUND (Continued):

In accordance with Board Policy A-18 and in accordance with Ordinance 459.4; separate agreements were developed without securing competitive bids for the professional medical services for Nerizza Andrada, M.D. and Lydia David, M.D. in an amount not to exceed \$42,000 each to provide physical exams and medical evaluations to all juveniles of detention health services as mandated by Title XV. Riverside Juvenile Hall requires that professional medical services be provided for sick call, medical evaluations and routine medical screenings. With only one full time physician for the department covering after hours call time, there was a critical need to request contracted physicians to assist in the provision of on-call duties. Dr. Nerizza Andrada and Dr. Lydia David have agreed to provide after hours coverage at other Juvenile Hall sites, as requested until recruitment and hiring of physicians could be completed by the hospital. The additional compensation for on call responsibilities for these two contractors has caused an overage of the original contracted dollars.

The hospital is currently in the process of hiring two full time physicians to begin on call duties. Once they have completed orientation, it will alleviate the need for contracted physicians to provide this needed service.

Therefore, the Hospital Director requests that the Board approve the abovementioned motions.
