BACKGROUND:

On October 4, 2011, the Board of Supervisors approved the construction agreement for Job Order Contract No. 004 between Angeles Contractor, Inc. and the County of Riverside. Various job orders were issued pursuant to the contract for the Department of Mental Health Tenant Improvements project located at 3125 Myers Street, Riverside, California. All projects have been inspected and found to comply with the contract requirements. This Board action will release the contract retention funds of \$35,655 to Angeles Contractor, Inc. The total approved job orders are within the overall project budget and no additional funding is required.

All costs associated with this agreement will be fully funded through State Funds, thus no net county costs will be incurred.
