BACKGROUND: On August 31, 2010, the Board of Supervisors approved Agenda Item 3.83, a Personal Service Agreement (RFQ# 44-100-2010 Zone 3M) between the Transportation Department and Sierra Pacific Landscape Contractor, Inc. for the maintenance of landscaping for L&LMD 89-1-C Zone 3 Menifee. The current agreement expires June 30, 2013. Given that this contractor has done the maintenance over the past three (3) years, the City of Menifee has requested extending the current contract with Sierra Pacific Landscape Contractor, Inc. for an additional two (2) years pursuant to the contract terms and continued use of seasoned staff to maintain the project. The Transportation Department will continue to be under contract to administer the L&LMD 89-1-Consolidated with the City of Menifee during Fiscal Year 2013-2014.

The annual amount of \$234,200 includes a contractual contingency, at the County's option, in an amount not to exceed \$50,000 annually for costs outside the scope of regular maintenance, including, but not limited to, replacement of broken sprinklers, plant replacement, soil amending and testing, damage due to vehicle accidents, and vandalism.

The Termination Clause remains unchanged and the County may terminate the Agreement without cause upon 30 days written notice.

County Counsel has approved the Agreement as to form.




**AMENDMENT NO. 1
TO PERSONAL SERVICE AGREEMENT
FOR LANDSCAPE MAINTENANCE**

The County of Riverside ("COUNTY") and Sierra Pacific Landscape Contractor, Inc. ("CONTRACTOR") entered into an Agreement (RFQ# 44-100-2010 Zone 3M) for L&LMD 89-1-C Zone 3, Landscape Maintenance for the Transportation Department on August 31, 2010 per Board Agenda Item 3.83. The Agreement has been extended for two (2) additional years of performance pursuant to its terms. The parties now agree to amend the Agreement as follows, effective June 30, 2013:

1. Period of Performance – Per Section 2.1, CONTRACTOR agrees to continue to provide COUNTY with the services described in the Agreement for the period from July 1, 2013 through June 30, 2015. Any extension of CONTRACTOR'S services beyond June 30, 2015 must be pursuant to a new agreement signed by both parties.


All other terms of the Agreement not modified herein shall remain unchanged and in effect.
