## **BACKGROUND**

The department is requesting the purchase of four (4) drives that will double the county's backup capacity. The existing IBM Tivoli tape library is in good working order and does not require replacement; just expansion to meet new service needs. The additional drives will provide backup and recovery services on an enterprise level; to include new services such as Active Directory and Customer Relationship Management software, as well as newly consolidated IT departments.

## PRICE REASONABLENESS

Purchasing released a Request for Quote ITARC149, solicitation notifications were sent to six (6) companies and posted on PublicPurchase.com and advertised on the County's Internet; with one (1) bid response received by Purchasing. Purchasing inquired as to the lack of responses from potential bidders, and the feedback from other vendors was that the potential bidders' either did not provide these services, or were not able to quote on IBM equipment to be competitive in the Riverside geographical area.

The quote received was reviewed by Information Technology Department staff and Logicalis meets the requirements of the request for quote scope of services. RCIT and Purchasing recommend that the award be given to Logicalis, Inc., as a responsive/responsible vendor, submitting a total project cost that shall not exceed \$63,600, plus \$8,324 annually for maintenance. Logicalis is extending to the County of Riverside pricing discounts on the IBM TS1050 expansion of 26% off the IBM list price and a 21% discount on the ongoing maintenance and licensing list pricing. These discounts represent the deepest non-federal rated customer discounts offered in any County contract.
