



**BACKGROUND:**

Clinicas De Salud Del Pueblo, Inc. will be implementing a peer-to-peer outreach project, ACCESS Project/Proyecto ACCESO, that will target 1,280 low to moderate-income residents in the eastern Coachella Valley.

The Sky Valley Chamber of Commerce & Community Center serves as a meeting site for the Community Council and CSA #104, Citizens on Patrol, Sky Valley Home Owners Association, Emergency Team meetings and drills, the mobile library and is a polling site for this remote community.

The Boys & Girls Clubs of Coachella Valley Foundation is hosting a fundraising event on March 9<sup>th</sup> to raise funds for their after school programs throughout the Coachella Valley.

The Valley Partnership's AmeriCorps Promote program provides tutoring services during classroom instruction and after school at elementary schools in the Coachella Valley Unified School District. The focus is on literacy, science, and English.

The Palm Springs Chamber of Commerce along with the Palm Springs Hospitality Association and the Greater Palm Springs Convention & Visitors Bureau are launching a major marketing campaign to promote Virgin America's new nonstop service to John F. Kennedy Airport in New York.

The Desert Hot Springs Boy's and Girl's Club will have their official Grand Opening on January 11<sup>th</sup>. The new facility will provide programs and services to the youth in the community.
