**SUBJECT:** 2012 Temecula Valley Balloon & Wine Festival Report – District III/III

**BACKGROUND:**

The event generated \$50,025 in revenue to the Regional Park and Open-Space District (District) from gate admissions, parking and camping fees. The event once again was a result of excellent cooperation between the community, Association, Riverside County Fire and Sheriff's Departments, US Immigration and Naturalization Service, City of Temecula, Metropolitan Water District, California Highway Patrol, Federal Bureau of Investigation and the District. The Association has requested authorization to proceed with plans to conduct the 2013 Balloon and Wine Festival at Lake Skinner Recreation Area in May and June of 2013. The District and Association, along with all festival partners, will work closely to ensure another successful event if your honorable Board authorizes the District to move forward with this event.
