

SUBJECT: Summarily vacating the right to accept a portion of Peoria Lane, in the Box Springs Mountain area, Supervisorial District, Fifth/ Fifth

RECOMMENDED MOTION: That the Board of Supervisors adopt Resolution No. 2013-007, summarily vacating the right to accept a portion of Peoria Lane.

BACKGROUND: The applicant is requesting the vacation of the excess portion of Peoria Lane to fully facilitate the use of his property. This portion of Peoria Lane was dedicated but not accepted by the County of Riverside on Parcel Map 13065 filed in Book 64, Pages 69 and 70, of Parcel Maps, Records of the County of Riverside. The current alignment of Peoria Lane was accepted by the County of Riverside by Parcel Map 20151 filed in Book 127, Pages 63 and 64, of Parcel Maps, Records of the County of Riverside. That portion of Peoria Lane offered on said Parcel Map 13065 that extends beyond that dedicated and accepted on said Parcel Map 20151 is excess and not required for right-of-way purposes. This vacation will not eliminate access to any parcels.





THAT PORTION OF PEORIA LANE AS SHOWN ON PARCEL MAP NO. 13065 FILED IN BOOK 64, PAGES 69 AND 70 OF PARCEL MAPS IN THE OFFICE OF THE RIVERSIDE COUNTY RECORDER LYING WITHIN THE NORTH HALF OF SECTION 23, TOWNSHIP 2 SOUTH, RANGE 4 WEST S.B.M., STATE OF CALIFORNIA DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE EASTERLY RIGHT OF WAY LINE OF PEORIA LANE AND THE NORTHERLY LINE OF PARCEL 4 OF PARCEL MAP NO. 20151 AS SHOWN ON MAP FILED IN BOOK 127, PAGES 63 AND 64 OF PARCEL MAPS RECORDS OF SAID COUNTY;

THENCE, SOUTH $01^{\circ}32'34''$ EAST ALONG SAID EASTERLY RIGHT OF WAY LINE 0.07 FEET TO AN ANGLE POINT;

THENCE, SOUTH $01^{\circ}24'00''$ EAST ALONG SAID EASTERLY RIGHT OF WAY LINE 411.80 FEET TO THE BEGINNING OF A TANGENT CURVE CONCAVE TO THE WEST AND HAVING A RADIUS OF 180.00 FEET;

THENCE, SOUTH AND SOUTHWEST ALONG SAID TANGENT CURVE THROUGH A CENTRAL ANGLE OF $26^{\circ}51'37''$ AN ARC DISTANCE OF 84.38 FEET TO AN ANGLE POINT AS SHOWN ON SAID MAP, A RADIAL BEARING THROUGH SAID POINT BEARS SOUTH $64^{\circ}32'23''$ EAST;

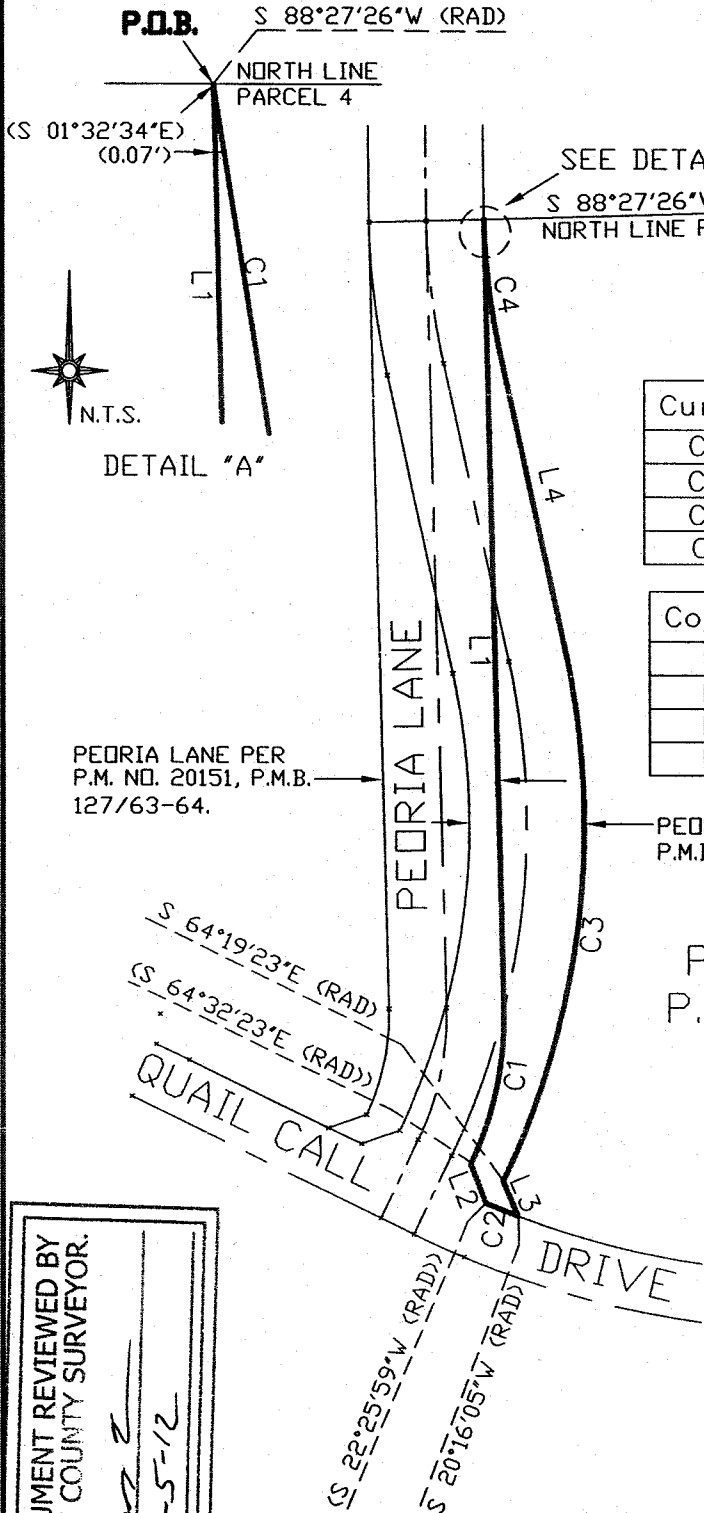

 WITHIN THE N 1/2 OF SEC. 23, T.2S., R.4W. S.B.M.

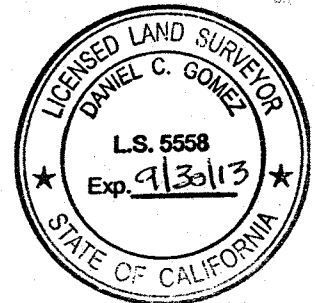

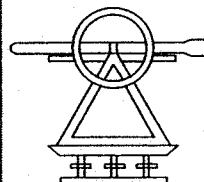

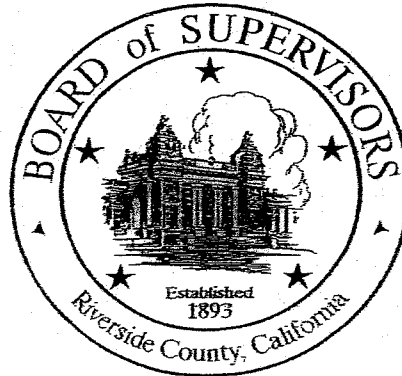
