SUBJECT: Low Income Health Program (LIHP) budget adjustment

RECOMMENDED MOTION: that the Board of Supervisors approve and direct the Auditor Controller to make adjustments, to estimated revenue and appropriations as shown on Attachment A.

BACKGROUND: The County received approval to begin enrollment in the Low Income Health Program (LIHP) beginning in January 2012. Effective July 1, 2012 a fund was established to track LIHP revenue and expenditures associated with payments to out-of-network service providers. In December 2012, an initial payment of \$8.5 million was received to reimburse out-of-network providers for actual and projected costs to provide services to eligible LIHP participants. The remaining funds, identified as deferred revenue, will be distributed to county departments to offset the cost of providing services for the LIHP. A budget adjustment is requested to reflect the revenue and expenses anticipated for this fiscal year.
