SUBJECT: Authorizing County Executive Officer to File Claims for Unclaimed County Property

RECOMMENDED MOTION: That the Board approve and authorize the Chairman to execute the attached letter to the California State Controller authorizing the County Executive Officer or their designee to file claims for unclaimed County property held by the California State Controller.

BACKGROUND: In accordance with the State of California's Unclaimed Property Law (Code of Civil Procedure §1500 et seq.), the California State Controller collects and holds unclaimed property deposited by third parties with that office under the law. Such property may include unclaimed refunds, payables owed, bank deposits, etc., but excludes real property.

The State Controller's Office then publishes information on such unclaimed property on its website. Owners of the property may file claims with the State Controller to recover these assets. One condition of the claiming process is that the party filing the claim be an officer authorized by the owner to do so. The action presented authorizes the County Executive Officer to file such claims on behalf of the Board of Supervisors to recover County property held by the state.


