BACKGROUND:

In accordance with Board Policy A-18 and in accordance with Ordinance 459.4; the Board approved on July 31, 2012; agenda item 3.53, the Agreement with Vache Chakmakian, M.D., without securing competitive bids for professional medical services in the aggregate amount of \$35,000 to provide physical exams and medical evaluations to all patients housed in detention health. RCRMC Detention Health requires that professional medical services be provided for sick call, medical evaluations and routine medical screenings to all patients held in the detention health centers throughout Riverside County. With limited full time physicians within the department covering sick call services, there is a critical need to request contracted physicians to assist in the provision of sick call services. Dr. Vache Chakmakian has graciously consented to provide additional coverage at the Indio jail facility twelve (12) hours per week and, as requested until additional recruitment and hiring of physicians could be completed by the hospital.

Even with aggressive recruitment efforts, Detention Health has not been successful in recruiting physicians for the vacant position at the Indio jail facility. Once RCRMC establishes permanent physicians, it will alleviate the need for contracted physicians to provide this needed service.

Therefore, the Hospital Director requests that the Board approve the abovementioned motions.
