**SUBJECT:** Approval of Election Services

**RECOMMENDED MOTION:** That the Board of Supervisors approve election services for the 40<sup>th</sup> Senatorial District Special Vacancy Primary Election on March 12, 2013.

**BACKGROUND:** California Elections Code § 10700 requires the Governor to issue a proclamation to call a special election due to legislative vacancies. A copy of the proclamation shall be sent to the Board of Supervisors of each affected county. Attached is the Governors proclamation calling a Special General Election to fill the vacancy in the 40<sup>th</sup> Senate District on May 14, 2013. Pursuant to California Elections Code § 10704 the Special Primary Vacancy Election has been scheduled for March 12, 2013.

The State will not reimburse the County for the cost of the special elections. Department will use funds on hand to proceed with the March 12, 2013 election, but expect to make a budget adjustment in the third quarter report as needed.


