Achieving the rank of Lieutenant JF, she was the first woman Quartermaster in the Coast Guard. On behalf of SPARS, she was invited to speak in Washington, D.C. and to the christening of the Coast Guard Cutter Stratton in Mississippi, and her service experiences were recently published in The Desert Sun.

In 1946, Harriet married her Navy sweetheart, Lee Writer, and moved to California, where they raised their three children. Returning to college, she graduated from USC with a teaching credential and taught junior high for several years. A true humanitarian, she volunteered as a hospital lay chaplain, was actively involved in church, and her knitting groups made sweaters for children around the world.

Harriet was a loving wife to her husband, who preceded her in death in May 2012, and a devoted mother, grandmother, great-grandmother, and friend. Her memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be dearly missed.
