**SUBJECT:** Approve the aggregate increase to Mental Health Managed Care Provider Contracts for FY 2012/2013. (All Districts)

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

1. Increase the previously Board of Supervisors approved aggregate amount for Managed Care contracts as outlined in Attachment "A" and "A-1" from \$5,250,000 to \$7,250,000 for FY 2012/2013;
2. Exempt the Riverside County Purchasing Agent from the sole source requirement when adding new vendors up to \$100,000 without securing competitive bids in accordance with Ordinance 459.4 while staying within the newly Board approved aggregate amount of \$7,250,000; and
3. Authorize the Riverside County Purchasing Agent to increase or decrease, and sign ministerial amendments for the Managed Care agreements as specified in Attachment "A" and Attachment "A-1" for FY 2012/2013 and shift funds while staying within the newly approved combined aggregate amount of \$7,250,000, and to annually renew these agreements through June 30, 2017.

**BACKGROUND:** On June 9, 2009, Agenda Item 3.35, the Riverside County Board of Supervisors authorized the Riverside County Purchasing Agent to contract with Managed Care providers as outlined in Attachment "A" and "A-1" on behalf of the Riverside County Department of Mental Health (RCDMH) for an aggregate amount of \$5,250,000. **SUBJECT:** Approve the aggregate increase to Mental Health Managed Care Provider Contracts for FY 2012/2013. (All Districts)

**BACKGROUND:**

However, recently the RCDMH performed an evaluation of its existing individual and agency providers, as outlined in Attachment "A" and "A-1", and found that the utilization of managed care services with individuals and agencies had grown due to an increase in Medi-Cal beneficiaries and the addition of the low income health care program, known as the Riverside County HealthCare Program. Additionally, an increase to the RCDMH's current managed care contract aggregate is required in order to accommodate current and future levels of care in preparation for the full implementation of Healthcare Reform in January of 2014.

The State mandates the RCDMH, by means of the Medi-Cal, Managed Care Mental Health Plan, to pay all providers for services rendered to Medi-Cal beneficiaries. Therefore, the RCDMH is requesting that the Riverside County Board of Supervisors authorize the Riverside County Purchasing Agent to increase the previously Board approved aggregate amount for individual and agency managed care service providers from \$5,250,000 to \$7,250,000 in order to assure that adequate financial provisions are in place to reimburse all Managed Care providers for SD/MC reimbursable services rendered in FY 2012/2013 and going forward.

**PERIOD OF PERFORMANCE:**

The agreements outlined in Attachment "A" and "A-1" have a period of performance from July 1, 2012 to June 30, 2013, and may be renewed annually through June 30, 2017.

**FINANCIAL IMPACT:**

The agreements outlined in Attachment "A" and "A-1" are funded by Medi-Cal and State funds, and have termination clauses in the event that applicable Federal, State and/or County funds become unavailable for service provision. There are sufficient funds in the department's FY 2012/2013 budget for this increase, and no additional County funds are required.

**PRICE REASONABLENESS:**

The current service rates for individual and agency providers are negotiated based on industry standards. The service rates are as follows:

Psychiatrist (M.D.)	\$1.25 per minute
Clinical Psychologist (Ph.D. or Psy.D.)	\$1.10 per minute
Marriage and Family Therapist	\$1.00 per minute
Licensed Clinical Social Worker	\$1.00 per minute
Medication Support Services	\$2.50 per minute
