### **BACKGROUND** (Continued):

This agreement is coming to the Board because the State of California has requested a change to funding language. There is no change to actual funding amounts.

CAPP funding provides childcare services to eligible families meeting criteria as set forth by the California Department of Education, in accordance with California Education Code. The Agreement will serve: families in need of subsidized childcare; children who are referred to the program as being at risk of abuse, neglect, or exploitation; and, other low-income customers who are not served by other subsidy programs, to facilitate self-sufficiency and stabilize family units. The average monthly cost per child is approximately \$472. Approximately 3,156 children were served during fiscal year 2011/12.

The Agreement was approved by the Board of Supervisors on July 31, 2012 (Agenda Item #3.41). Amendment #1 was signed by the Board of Supervisors on August 28, 2012 (Agenda Item #3.79). Amendment #2 will increase the Minimum Days of Operation Requirement from 195 to 245.


